# Efforts underway to rehabilitate buffer fences

**MAUN** - Efforts are underway to rehabilitate the buffer fences this financial year.

Principal veterinary officer, Dr Bruce Mafonko said this on Saturday when responding to comments from the chairperson of North West Integrated Farmers Association.

Dr Mafonko admitted that the fences were not in good condition and as such, they have requested funding for their maintenance.

He emphasised the importance of the buffer fences in Ngamiland region saying the fences were critical for disease control and protection of both livestock and wild animals.

Dr Mafonko also said they intend to turn zone 2e into a green zone to enable greater access of Ngamiland beef to high value markets.

Earlier on, the association chairperson Mr Simon Bogosi complained about the bad state of the fences which had resulted in free movement of both livestock and wild animals.

As a measure to control Foot and Mouth Disease(FMD), the livestock that cross the buffer fence into wildlife area is killed and burnt. Mr Bogosi therefore said this act impoverished farmers and called on the ministry to devise other alternatives.

He said it was a misconception for one to report that FMD vaccination alone without cordon fences could be a panacea for eradication of the disease.

Mr Bojosi recommended that buffer and cordon fences should be erected, adding that there should be implementation of communal fencing where possible to reduce interaction of cattle and buffaloes.

He also complained that the protection zone at Hainaveld ranches which aimed to prevent the spread of FMD into commercial ranches was constructed without conducting environmental impact assessment (EIA) and thus had caused conflict as some farmers argued that the fence cuts off communal grazing land.

The Hainaveld farming block was originally zoned for commercial ranch development under the Tribal Grazing Land Policy of 1975 and Mr Bojosi decried non-compliance of the policy at Hainavled arguing that part of the area had been converted to game farming without formally consulting with the community accordance with the EIA act.

However, he appreciated the government intention to declare Zone 2e into a green zone.

He cited areas such as Hainaveld ranches, Nxauxau and Xaxa saying the areas had not been exposed to the disease for years.

Meanwhile, Dr Mafonko dismissed reports that cattle from North East Zone 6b where FMD outbreak occurred in 2023 were kept at Makalamabedi quarantine while awaiting slaughter at Maun Botswana Meat Commission plant.

He explained that the animals were transported straight to the slaughter facility, adding that an arrangement was made to ensure the exercise does not disadvantage Ngamiland farmers to use the quarantine and the abattoir as well. **BOPA**

## MP pledges housing for underprivileged

Takatokwane MP, Mr Jacob Kelebeng has announced plans to build houses for the needy through the Jacob Kelebeng Foundation.

Speaking during a kgotla meeting at Ditshegwane and Kgare/Sebotswane on Friday, Mr Kelebeng said the foundation aimed to build at least five houses for disadvantaged individuals in his constituency within five years.

MP Kelebeng, who is also the Minister of Sport and Art, said the foundation sought to elevate sport in the region and had already funded tournaments in the constituency last December. He mentioned that the foundation also planned to support individuals living with disabilities in his area as well as improving the plunging academic performance in his constituency.

Letlhakeng clinic, Letlhakeng District Council Secretary, Mr Tsholofelo Molaodi stated that since primary health care

Mr Kelebeng stated that the intention was to host career fairs for students to help them identify their career paths at an early age.

He also challenged councillors in his constituency to support communities by developing their own projects. Concerning the recent load shedding due to the breakdown of the ailing Morupule B Power Station, he stated that the government was considering building another power station.

Mr Kelebeng also said the government was stepping up its efforts to develop solar power stations.

In response to residents' concerns about congestion at

Letlhakeng clinic, Letlhakeng District Council Secretary, Mr Tsholofelo Molaodi stated that since primary health care services had been relocated to councils, outreach services would commence. He was confident that the congestion would abate.

He attributed the congestion at Letlhakeng clinic to a lack of heath outreach services and stated that they have already identified a vehicle that would be used for outreach services. Mr Molaodi said the council maintenance crew would continue conducting minor repairs to address the dilapidated infrastructure in schools. Still in Kgare/Sebotswane, residents pleaded with the land board to expedite plot allocation and also requested a kgotla shelter and a mobile clinic. **BOPA** 

## 'Individual commitment plays role in combating GBV

**GABORONE** - The Minister of Youth and Gender Affairs, Ms Lesego Chombo has said the number one priority in the fight against gender-based violence (GBV) is to prevent it from occurring. Delivering a keynote address during the Inaugural United Congregational Church of Southern Africa (UCCSA) Trinity anti-GBV workshop in Gaborone on Saturday, Ms Chombo said it was important to promote and create awareness about ways to prevent GBV rather than to react once the violence or death had occurred. "The priority is to prevent and this is why we say the individual commitment and participation in combating GBV plays a much more bigger

role, because this scourge is getting worse," she said.

She commended UCCSA Trinity for organising the anti-GBV workshop, which was preceded by a walk and encouraged the church to cascade the message to the young ones in Sunday school.

By being intentional about the lessons they teach and the culture they inculcate in children in Sunday school, she said the church would contribute positively toward gender equality and GBV fight.

Minister Chombo said the church had so much power to influence, shape and build the society. "Because our spirituality is the very essence of our being and our spirituality guide us, can we use this power to teach our

children about equality and let us also teach our young boys about vulnerability and positives about masculinity," she added.

Furthermore, Ms Chombo said it was also through a multi-sectoral approach and gender mainstreaming strategy that the fight against GBV and promotion of gender equality to address inequalities could be achieved.

She also expressed concern that some cultural and societal norms and practices had been deliberately twisted to negatively influence perceptions that perpetuated violence.

Giving a police perspective and envisaged solutions, Botswana Police Service (BPS) Commissioner Ms Dinah Marathe said GBV was fuelled by deep-seated cultural challenges, economic hardships and abuse of substances, among others.

"Women and children are brutally murdered and raped by the people who are supposed to be their protectors," she said.

She expressed concern that GBV had become a persistent and growing vile that continued to attack humanity. Ms Marathe reaffirmed BPS's commitment in ensuring the safety and security of all citizens through prevention and detection of crime, for protection of lives and property. The BPS commissioner said they would continue to ensure provision of all the necessary assistance to afford GBV survivors the safety and confidentiality they deserved.

"We are also intentional in ensuring that GBV reports are

attended swiftly and that our services are accessible to all. So, let's come forward and seek for help, our doors are open," said Ms Marathe. She said GBV reports could be made at police stations, in person, or via telephone, either disclosing identify or remaining anonymous.

Ms Marathe called upon all individuals and stakeholders to actively participate in the fight against GBV, commending the church for playing an active role in providing better support systems for the survivors.

The church, she said was a critical partner in crime prevention through fostering a culture of love, respectful relationships and mutual support, as it was advantaged to advocate for policy change. **BOPA**

## WUC launches debt recovery, amnesty drive

**GABORONE** - Water Utilities Corporation (WUC) has taken a bold step in tackling its staggering customer debt, which exceeds P1.55 billion, by launching a mass debt collection initiative coupled with a debt amnesty programme as of April 1.

In an interview, WUC coordinator for public relations

and events management, Ms Onalethata Mpopang explained that the campaign aimed to address the total reported debt of P1 551 329 842 as of February 28.

Of this figure, domestic customer debt stands at a startling P833 246 965, while government accounts total P501 773 172, Business debts follow at P153 579 505, with local councils rounding out the list with P62 730 200.



Water Utilities Corporation coordinator for public relations and events management, Ms Onalethata Mpopang said they had taken a bold step in tackling customer debt, which exceeded P1.55 billion, by launching a mass debt collection initiative coupled with a debt amnesty programme as of April 1.

Furthermore, Ms Mpopang said that areas with the highest debts were Gaborone and Francistown followed by Mochudi, Kanye and Molepolole villages. Through this mass debt collection drive and the debt amnesty, WUC aims to significantly reduce outstanding debts, enhancing the corporation's liquidity in the process.

Moreover, Ms Mpopang said the initiative sought to foster positive customer relationships, acknowledging factors that have contributed to household debt, such as poverty alleviation through backyard gardening initiatives and the financial impact of COVID-19.

She also encouraged customers to clear their outstanding bills, which would also pave the way for a smooth transition to the Smart Prepaid Water Metering Solution.

The campaign, set to run from

April 1 through June 30, aims to reposition WUC as a progressive entity within the new Botswana while fostering improved service delivery and community partnerships.

"Customers with outstanding debts will receive an SMS notifying them of their eligibility for debt amnesty," Mpopang clarified. In addition, communication regarding the initiative will be delivered through various channels, including social media, television, radio interviews, SMS notifications and on-the-ground activations.

She said any domestic customer with a water bill over 90 days old was eligible for the amnesty, encouraging customers to apply at their nearest WUC office or through the WUC website, where select offices would have extended operating hours to assist.

To ensure fairness and transparency, customers will be informed of their outstanding debts and the terms and conditions of the debt amnesty programme. Once an application is submitted and approved, customers will receive a copy of their debt amnesty application form, she explained.

Ms Mpopang said that the media was playing a crucial role in this initiative, with a target of reducing domestic debt by 50 per cent by the end of the campaign while also improving the corporation's liquidity.

Looking ahead, she said the introduction of the Prepaid Water Metering Solution was expected to prevent future debt accumulation, paving the way for a sustainable and accountable water service delivery system.

## Health ministry commits to end maternal mortality

**GABORONE** - The Ministry of Health has reaffirmed commitment to tackling maternal mortality and ensuring healthy beginnings for every mother and child.

Speaking at the World Health Day commemoration in Gaborone yesterday, the Assistant Minister of Health, Mr Lawrence Ookeditse, highlighted the ministry's strategic interventions aimed at reducing preventable deaths through comprehensive healthcare measures.

Mr Ookeditse said one of the core pillars of the ministry's strategy was strengthening antenatal and post-natal care.

He stressed the importance of ensuring that all pregnant

women received early and regular check-ups, including promoting safe hospital deliveries by skilled personnel to mitigate complications and reduce maternal mortality.

He said the ministry also planned to increase access to family planning services, particularly long-acting reversible contraceptives, to prevent unplanned pregnancies that could lead to complications for both mothers and babies. Mr Ookeditse emphasised the vital role of public health campaigns in addressing maternal mortality.

He said it was time campaigns focussed on raising awareness in communities about safe pregnancy practices, maternal, and new-born health be resuscitated as they ensure that every community was equipped with the knowledge to protect maternal and child health.

Another key focus, Mr Ookeditse mentioned was capacity building within the health-care sector.

He called for intensified training for healthcare professionals, especially in emergency obstetric care and new-born resuscitation.

He further said the ministry was also committed to ensuring that maternity wards were properly equipped to handle complications during labour and delivery, ensuring that no woman was left vulnerable due to a lack of resources or expertise.

In addition to internal improvements, Mr Ookeditse underscored the importance of strengthening collaborations with strategic partners.

He said that included continuing vaccination programmes to protect both mothers and new born babies from preventable diseases.

Furthermore, he pointed out that the ministry aimed to enhance partnerships with stakeholders to improve health-care infrastructure and maternal health policies, ensuring that all pregnant women and their children had access to the care they needed.

Mr Ookeditse reiterated the ministry's determination to continue working with all sectors to reduce maternal mortality and build a healthier, safer future for all Batswana.

Mr Ookeditse said the theme for the World Health Day: Healthy Beginnings, Hopeful Futures emphasised the importance of maternal and new-born health, a fundamental pillar in building a healthier society. *BOPA* 

## National Development Plan 12 consultations start

**GABORONE-** The National Planning Commission (NPC) will start a nationwide National Development Plan 12 (NDP 12) stakeholder consultations today.

Minister for State President, Mr Moeti Mohwasa said this at a press conference on the extension of the Second Transitional National Development Plan and key deliverables related to development of NDP 12 in Gaborone yesterday.

He said consultations would start in Gaborone, where he would engage with leadership on the NDP 12 preparations.

"Consultations is not only a key imperative of this administration to ensure respect for people's rights but a necessary ingredient in the national development planning process," he said.

Mr Mohwasa said he had directed the NPC to ensure wide stakeholder engagement as much as possible throughout the NDP 12 preparation process.

He said government was committed to engage closely with Batswana, to ensure their aspirations were taken on board in crafting NDP 12. Also, he said the extension of the second Transitional National Development Plan (TNDP) provided for extensive consultation with key stakeholders and to also take into consideration the promises of the ruling party in the planning process.

Minister Mohwasa said the implementation of the NDP 12, which was expected to commence

on April 2025, was delayed, as the time that was available was too short to allow for meaningful engagement with stakeholders.

He said the government took a decision to extend the second TNDP by seven months, from April to October 2025, which also allowed for the constitution of the Advisory Council of the National Development Mission, which provided oversight on the work of the National Development Commission.

Mr Mohwasa said NDP 12 would take into consideration the ambitions of the ruling party, such as its ambitious objectives of stirring an economic growth of 10 per cent and creation of 500 000 jobs in five years among others.

"This will only be achieved if all stakeholders work together. So NDP 12 will be a vehicle that will help to contribute ideas that will take us to our destination" he said. Mr Mohwasa said the whole planning process would be expected to end in November when Parliament approves the plan.

The NPC acting Commissioner General, Ms Keganele Malikongwa said the commission was in the process of developing NDP 12, which she said would be transformational.

She said the government had high targets, which called for changing and overhauling processes to meet the high demands, adding that the NPC was also benchmarking on high performing countries on how to transform.

## 'Alcohol Levy fund used for intervention programmes'

**GABORONE** - The Assistant Minister of Health, Mr Lawrence Ookeditse says the Botswana Unified Revenue Services (BURS), who were charged with the collection of the alcohol levy since 2019, has collected a total of P4 006 029 956.16 since its inception.

Answering a question in

Parliament on Thursday, he said it was worth noting that the ministry only received 10 per cent of the alcohol levy funds for the alcohol programmes and interventions, therefore, the expenditure report provided was only based on funds received by the ministry of health.

He said in 2018 to 2023, the ministry received P214 812 812.28 in alcohol levy funds and the total expenditure was P166 208 000.03.

The minister further stated that on tobacco levy, they received P196 731 157.94, adding that the financials for 2024 and 2025 have not been provided, as they have not been verified yet.

He said the number of individuals seeking and receiving treatment through the alcohol levy facilitation has grown steadily from 668 in 2017, to a cumulative figure of 3006 in 2023.

"It should be noted that substance use disorder was a chronic relapsing brain disease and clients continue to be in recovery and needing support, not only from the health sector but from families, communities and legislative support that aims at supply suppression and demand reduction on substance use," he said.

Mr Ookeditse said for tobacco levy, the number of individuals

in the rehabilitation programmes across non-governmental organisations that have been funded through the levy fund stands as 276.

He said the ministry of health developed a strategic plan for alcohol and substance use in 2022, which was currently being implemented with the aim of providing harm reduction services for people affected by alcohol and other substances.

The assistant minister said most people with substance use disorders required outpatient services, which were offered at psychiatric clinics in the hospitals.

He said it was for this reason that they are constructing an inpatient rehabilitation centre at old Sekgoma Memorial Hospital Institute of Health Sciences in Serowe, which was expected to be operational in the third quarter of 2025.

The centre, which will have 50 beds comprising of 30 for adults, 20 males, 10 females and 20 for adolescents who will be 10 boys and 10 girls will offer inpatient and out-patient services, he said.

Similarly, he said, the ministry through tobacco levy implementation committees has set aside P 60 million to establish a rehabilitation center where the ministry of health has identified need. *BOPA* 

## MPs adopt social justice audit motion

**GABORONE** - Parliament has adopted a motion requesting government to conduct a comprehensive social justice audit.

The motion, which garnered support from legislators recently, was presented by Bobirwa MP, Mr Taolo Lucas.

He emphasised the need for all members of Parliament to commit to take action by the end of their term to bridge the gap between the affluent and the impoverished, as well as the developed and the neglected sectors of society.

"It is unfortunate for some individuals to believe that the disparities we see today are a divine decree that must persist.

These socioeconomic differences are man-made, and it is indeed men who must work

towards rectifying them," said Mr Lucas

Mr Lucas indicated that many of the pressing challenges could be addressed through the National Development Plan 12.

He called for projects aimed specifically at resolving disparities in the distribution of essential infrastructure, including hospitals, secondary and tertiary schools as well as paved roads.

He also highlighted the potential for constitutional review to mitigate social differences among various tribes in the nation.

He added that the motion aimed to correct the injustices perpetuated by previous administrations.

Maun West MP, Mr Caterpillar Hikuama, pointed out that the societal differences were deeply institutionalised in Botswana's legislative framework. He noted that policies like assimilation have exacerbated inequality, particularly in education, where regions such as Kweneng, Kgalagadi, and Ngami have shown alarming levels of poverty and underdeveloped educational resources.

He further asserted that a social justice audit would generate a critical report with recommendations to guide government actions moving forward.

He underscored the importance of addressing issues such as child labour, where children often find themselves forced into roles as herd boys and farm labourers, situations worsened by the prevailing disparities in resource allocation. *BOPA* 

### Impact of local per diem under scrutiny - Mmolotsi


GABORONE - Ministry of Environment and Tourism through the Department of Tourism conducted a mini survey on the impact of the implementation of local per diem from July 31 to August 7, 2024. Minister of Environment and Tourism, Mr Wynter Mmolotsi was answering a question in Parliament on Thursday.

He said the department sampled 500 licensed establishments out of the 1402 licensed and only 215 responded to the study.

He said the ministry due to insufficient resources, could not undertake a comprehensive study to substantively determine decline and or increase in occupancy rates of the small to medium hotels, lodges and guesthouses.

Mr Mmolotsi said the results for the mini survey showed that majority of accommodation facilities recorded a decrease in revenue since the introduction and implementation of the local per diem.

This, he said, also revealed that civil servants negotiate for reduced room rates and also shared rooms. Mr Mmolotsi stated that the ministry has recorded a total of five facilities; four bed and breakfast being Shatiha Cottage, Place of Beauty, Thahika and Yalama as well as one guest house being Lekunutu, which closed down during the financial year 2024/25. He said lack of business was highlighted as a reason for closure, which might not necessarily be attributed to the implementation

of policy on local per diem. Furthermore, he said the ministry was informed by the industry players that some of the facilities laid off some of their employees.

Mr Mmolotsi said the impact of local per diem would be determined through the comprehensive study to be undertaken.

He indicated that plans were under way to have stakeholder

engagements so as to amend the guidelines for the local per diem with the aim to ensure that the implementation would not adversely impact small to medium hotels, guest houses and lodge operators.

Moreover the ministry through the Department of Tourism was also in the process to conduct a comprehensive study, which would target both the tourism industry being accommodation providers, public sector trade unions and civil servants. The minister noted that the comprehensive study would be able to advise the ministry and the government on the true impacts of local perdiem on the broader hospitality sector. He said one of the recommendations of the mini survey was that the government should consider

paying accommodation costs and civil servants be given meal allowances. The ministry would continue to engage with the relevant stakeholders and ensure facilitation and growth of the tourism sector.

MP Barongwang also requested the minister to provide the number of small to medium accommodation providers that had closed their facilities since the policy's implementation.

He further implored the minister to outline measures put in place to ensure that the local travel per diem policy did not adversely affect the small to medium hotels, guest houses and lodge operators.

Mr Barongwang also asked how the government ensured that the government travel expenditure directly supported small to medium, dully registered, and tax compliant local businesses.

## Lack of funds delays BR salary structure implementation

**GABORONE** - Botswana Railways organisational structure was last reviewed in 2019.

Answering a question in Parliament on Wednesday, the Assistant Minister of Transport and Infrastructure, Mr Keoagile Atamelang said consultation with the union on the structure was concluded in June 2021 and implementation was effected in September 2021.

He shared that an independent consultant did the salary review structure during the financial year of 2022/2023 and the Board of Directors approved it in March 2023 for implementation, subject to availability of funds.

"To date, management has not been able to implement the approved salary structures despite the Board's approval because the organisation's financial situation has not improved to accommodate the budgetary requirements of the new structure," he said.

Mr Atamelang said salary levels of Botswana Railways across positions are guided by the Botswana Railway Compensation and Benefits policy, therefore the salary levels and their implementation are guided by the financial performance of the organisation as well as the prevailing market rates per job position.

He said this was done through participation in annual market compensation and benefits comparisons by the private sector consultations as engaged by Botswana Railways. The assistant minister said in the past, Botswana Railways engaged Tsa Badiri Consultants, a private consulting human resource firm and furthermore, the organisation adopted a pay policy at the 50th percentile of prevailing market compensation rates for every survey job position.

Mr Atamelang said the disparity in terms of pay between lowest and highest job grades in the organisation was not substantiated as the current salary market survey findings show that the executive job positions were found above the market per findings by an independent consultant.

He further noted that the consultant who was engaged to do the salary structure made some of the observations that included that employees among the unskilled, semi-skilled to clerical were paid well within the organisation of 50<sup>th</sup> percentile.

Mr Atamelang said the other observation was that the basic salary of the General Manager has been pegged at the Permanent Secretary level as it is the same for other parastatals of the same level, however the survey indicated that the total compensation and benefits were well below compared to other counterparts.

He noted that the Board, subject to funds availability, had approved the new salary structure for implementation, therefore the new salary structure would be implemented once the organisation's revenues exceeded its operating costs.

Selebi Phikwe West MP, Mr Reuben Kaizer had asked the minister to state when last was Botswana Railways organisational and salary structures reviewed and implemented. He also asked if the two structures were both reviewed and implemented across all positions, and if not, why was there a huge disparity between the highest paid and the least paid employee and also when will there be a review and increment of salaries for the staff. *BOPA*

**GABORONE** - Government continues to explore opportunities to engage different investors in the mining and energy sectors, expressing hope that potential backers will come forward to develop key projects.

Answering a question in a Parliament on Friday on behalf of the Minister of Minerals and Energy, Minister of Environment and Tourism, Mr Wynter Mmolotsi, said that while there were no specific timelines, government was optimistic about attracting investors for the Mmamantswe Coal Project.

Mr Mmolotsi provided background on the project, noting that Aviva Corporation once owned the Mmamantswe Coal Exploration Project, which boasts an estimated 1.3 billion tonnes of coal resources.

The initial plan involved establishing a coal mine capable of producing 10 million tonnes per annum, which would support a 1 000 megawatt (2x500mw) export power station for Eskom.

However, challenges emerged in 2012, leading to the project's failure, after which the mineral concession was acquired by African Energy.

The new owners also aimed to attract investment for its development. Unfortunately, the prospecting license under African Energy expired in 2021 and was not renewed due to the company's inability to secure an investor. As it stands, no mineral concession currently exists for the area.

Kgatleng Central MP, Mr Mpho Morolong, had sought clarification from the minister regarding the current status of the Mmamantswe Coal Mine, questioning whether the project had been officially shelved and the reasons behind such a decision.

He also inquired about any government actions being considered to revive or repurpose the project, given its potential economic benefits for the region, including local employment and infrastructure development opportunities in Kgatleng Central.

Mr Morolong highlighted that the project was expected to boost the economies of surrounding villages such as Ramotlabaki and Olifantsdrift, particularly in relation to the anticipated expansion of the border post for coal supply to South Africa.

In a related matter, Selebi Phikwe East MP, Mr Kgoberego Nkawana, asked the minister to clarify whether the non-renewal of African Energy's contract was indeed due to the company's failure to attract investors.

He posited that licensing was crucial for attracting investment, suggesting that the government may have hindered potential investment opportunities by not renewing the prospecting license.

In response, Mr Mmolotsi clarified that African Energy had been granted a prospecting license but failed to secure an investor within the allotted time.

After the expiration of the license, the company requested a renewal, which was ultimately denied to allow other potential companies the chance to explore the project. **BOPA**

## Farmers implore BMC to revise rates

**MAKALAMABEDI** - Residents of Makalamabedi have called on the Botswana Meat Commission (BMC) to consider an increase in buying prices of their cattle.

They complained that the Maun abattoir was competing with private abattoirs, which purchased animals at a better price of P36 per kg compared to the BMC's P31 per

The residents aired their views during a kgotla meeting addressed by the Vice President, Mr Ndaba Gaolathe over the weekend.

Residents said farmers had been playing a vital role in the success of BMC but the low prices had forced majority of the farming

community to resort to selling their animals to the private abattoirs and some local butcheries because they paid better and on time.

They said it was unfair as in other areas considered green zones, farmers were reaping the benefits of their animals as they enjoyed European Union lucrative markets. Farmers proposed a standard buying price, which would promote equity and incentivise the supply of cattle to the BMC.

Increasing the cattle-buying price, they said, would also boost cattle industry, citing that farmers would take advantage of the increase and sell their cattle in numbers.

Village Development The Committee chairperson,

Lebogang Kelebang said BMC should up its game to restore the farmers waning confidence in the

Farmers, he said depended on cattle as their source of income and blamed low prices to lack of lucrative market from the district as a result of Foot and Mouth Disease (FMD).

"Our region has been declared a red zone and yet residents depended on rearing of livestock for survival but they were not reaping the benefits from their animals," he said.

Mr Kelebang said if the increase of purchase price was not successful, the abattoir should strive to secure more markets for Ngamiland beef.

He noted that farmers spent a lot in management of their livestock but was unfortunate, as they could not recover the costs they incur in cattle production due to low prices.

Mr Kelebang also decried delay in payment of farmers by BMC and called on the abattoir to provide efficient and timely payments to

He also called for improvement of infrastructure such as roads to the agricultural production areas, citing the Xedumo-Samedupi-Nxaraga road, which he said could help enable efficient transportation of imports and exports and access to markets.

human-wildlife-conflict was also highlighted as a threat to pastoral and arable farming and Mr Kelebang called for the electrification of the protection fence as a measure to reduce elephant migration and stock theft. Maun East MP. Mr Goretetse

Kekgonegile pointed out that the market challenges incurred by farmers had rendered the cattle farming less profitable.

He said pastoral farming was paramount to the economy of the region and proposed that the government should consider introducing the agricultural guarantee schemes so that farmers could gain more from pastoral farming."Some farmers in other regions used their livestock as security to access financial assistance from institutions but here, farmers cannot do that because their animals were not accessing the rewarding market," he added.

He also emphasised that provision of adequate infrastructure was paramount for boosting agriculture production and food security, citing energy, good road networks and telecommunication among others. BOPA

## Chinese cars gain popularity in Egypt

**CAIRO** - Cruising through the bustling streets of Cairo in his sleek red Chinese-made sedan, Omar Mohamed exemplifies a growing trend in Egypt's automotive market the surging popularity of Chinese cars. "I didn't hesitate to buy a Chinese car a few months ago because of its good features for a reasonable price," he told Xinhua, noting that the cost of a brand-new Chinese car was often comparable to that of a used European model.

At first, the young man saw owning a Chinese car as a risk, given their reputation for frequent

"However, this perception has shifted over the past five years, as Chinese cars have improved significantly and unexpectedly," Mohamed said.

According to the Automotive Market Information Council (AMIC), Egyptian consumers have increasingly embraced Chinese cars, not just for their affordability but also due to their improved safety features and quality, making them a preferred choice in the local

This shift has reshaped the country's automotive landscape. contributing to a decline in both new and used car prices. "Chinese cars have played a major role in bringing down car prices, especially in the budget-friendly sedan and hatchback segments,' said Ahmed Nasser, a sales manager at a leading Egyptian car dealership.

"The surge of the U.S dollar against the Egyptian pound, in addition to the shortage of imported vehicles and the high rates of inflation had pushed the prices too high. However, the

spread of Chinese cars in the Egyptian market has brought relief to Egyptian consumers who have endured years of inflated vehicle

Nasser explained that dealers, faced with the affordability and feature-rich offerings of Chinese models, were compelled to reduce their profit margins and eliminate overpricing to remain competitive.

He predicted that Chinese cars would "sweep" the Egyptian market in the next few years, especially those manufactured or assembled locally.

"After-sales maintenance for Chinese cars are excellent, especially since most Chinese brands in Egypt have authorised dealers who have been operating in the Egyptian market for decades," he said.

According to the AMIC, Chinese car sales surged by 33.6 per cent between January and November 2024, with brands like Chery, MG and BYD securing prominent positions among the top 10 bestselling car brands in Egypt.

In January 2025 Chinese cars topped passenger car sales, with 3,301 vehicles sold, a significant increase from the 1 721 units sold in January 2024, as reported by the AMIC. Osama Aboul-Magd, head of the Egyptian Automotive Dealers Association, attributed this market transformation to substantial investments and the localisation of automotive production.

He highlighted the significant financial commitments made by Chinese automakers, including US\$100 million for Geely's production and US\$ 135 million for MG's manufacturing. Xinhua.



## **Ambrose Academy raises awareness on autism**

GABORONE - Ambrose Academy in Gaborone North commemorated World Autism Day on April 2 by embarking on a walk to raise awareness on the autism spectrum disorder (ASD) condition.

The academy engaged the 2024 World Rally Raid champion, Ross Branch as the chief walker. Making a call for inclusively on autism, a parent, Ms Bokang Opelokgale in an interview with *BOPA* called for inclusiveness to foster acceptance, saying it could only come with awareness.

"And awareness can only be possible if each and everyone of us, can speak on behalf of the voiceless, the children living with autism," she said.

Ms Opelokgale is raising a 10-year-old who is autistic and as such, she said it was their duty to

teach people around them about this developmental condition.

The ASD is a developmental disability caused by differences in the brain, and can cause significant social, communication and behavioural challenges.

She said dealing with autistic children had challenges noting that both caregivers and autistic children needed the support they could get from people around

Furthermore, she said when people are aware of ASD and the challenges autistic children went through, they would be in a better place to be of assistance in whatever way they could.

She said learning about ASD meant one could encourage and celebrate the uniqueness, abilities and interests of autistic individuals, recognising that autism was a spectrum.

Also, Ms Opelokgale said they encountered challenges, particularly of resources for autistic children.

"Our children need resources and support to reach potential that other normal developing children reach. It is unfortunate that the majority of children in Botswana do not have access to adequate resources," she said, adding that being aware of ASD would mean acceptance. She said when accepted, societal inclusivity would be easy and government could also resourcefully absorb them in their human resource noting that an autistic child grows into an autistic adult, as

autism does not end at 18 or 21.

Ms Opelokgale said there was also need for advocacy for autism in the workplace. Moreover, she said in her journey of raising a child with special needs, she realised that viable income to cater for all their needs was necessary.

"They need special equipment at school as their fine motor skills are not yet developed, they go for speech therapies, physiotherapy, occupational therapy and the school fees at a special institution," she said.

The 2025 World Autism Awareness Day was observed under the theme: Advancing Neurodiversity and the UN Sustainable Development Goals (SDGs).

The theme highlighted the intersection between Neurodiversity and global sustainability efforts, showcasing how inclusive policies and practices could drive positive change for autistic individuals worldwide and contribute to the achievement of the SDGs. *BOPA*

## NWDC welcomes budget estimates

MAUN - North West District councillors have approved the 2025/26 budget estimates with mixed feelings as some argued that it was inadequate to undertake all the planned developmental projects in the district.

The district, they said was faced with many challenges and the estimated budget would not enable the council to execute its mandate efficiently and effectively for the betterment of the communities.

Legislators shared their views during a recent special full council after presentation on the final budget estimate by the finance committee chairperson, Mr Diare Baoketsi, who informed them that the 2025/26 final recurrent budget ceiling for the council amounted to P250 238 400, which comprised of P239 320 400 Revenue Support Grant (RSG) and P10 918 000 of income from own source.

The house also learnt that the RSG showed a decrease of P40 907 070, which translates to 14 per cent from the P227 470 of 2024/25 fiscal year.

Included in the RSG, Mr Baoketsi said was the P10 696 326 for operational costs of clinics as they would be relocating to councils during this financial year. Personnel emoluments and other contractual operations for clinics, he said were not included

in the above allocation.

The house also learnt that the overall budget for the council had decreased by P41 638 010 from P291 721 250 to P238 400 and that the income from own source had also been reduced from P11 648 940 in 2024/25 approved budget to P10 918 000 due to reduction in cash flow leading to lower investments.

Mr Baoketsi further told councillors that the largest share of the budget, which amounted to P119 976 210, went to personnel emoluments, which provided for employees' salaries, members allowances, pension, overtime and scarce skill allowance.

"The vote has decreased by P22 134 213 as the overtime has decreased due to budgetary constraints. Also terminal benefits for councillors' end of term has reduced as the council only budgets for one or two councillors in case they exit before end of term due to unforeseen circumstances," he added.

Special expenses vote, which provides for relief of destitute persons, food and accommodation, school stationery and others, he said had the second largest share of the budget at P76 499 030, which represents 30 per cent of the budget.

The remaining balance of the budget, which amounts to P23 004 100 and represents nine per cent goes to establishment

expenses, he said.

While fellow councillors appreciate that the mandate of the council was to bring services closer to the people, they expressed concern that with such a small budget, they were going to fail the community.

Cllr for Samedupi/Chanoga, Mr Nico Folae expressed frustration, saying the said budget would limit the council to deliver projects as expected.

Nominated councillor, Mr Kebareeditse Ntsogotlho said such was a wake-up call for the council to intensify collection of revenue to augment its budget, noting that fellow councillors should appreciate that the government was facing an economic crisis, hence reduction in budget allocations.

He also urged leaders to explain the current situation to communities in their respective areas for them to appreciate and also inform them that other projects would be implemented through other programmes such as Ipelegeng and Community Constituency Fund (CCP).

Council secretary, Mr Thatayotlhe Balapi informed the house that they had been advised to maximise on the little resources they had, noting that they had to reduce on the expenditure. He also assured the house that if the financial situation improved, they would make some proposals to cater for some projects in the plan. *BOPA*

In an interview with BOPA, Assistant Superintendent, Eric Dambe of Serowe police said they have arrested a 23-year-old man of Majwanaadipitse settlement after he stabbed another man who's age was not identified with a sharp instrument at the village bar on April 5.

The accused is alleged to have stabbed the victim with a sharp object suspected to be a knife on chest after a heated argument over alcohol.

### Suspect shoots himself to death

**SEBINA** - A suspect in a threat to kill incident has shot himself to death last week Friday.

In an interview with BOPA, Tutume Police station commander Superintendent Lesego Kgosiemang explained that the suspect, a 43-year-old man of Magapatona ward in Tutume was wanted by the police for threatening to kill his ex-girlfriend at her work

He said at the time, she did not report until her colleagues told her that he had come to her work place on foot and looked suspicious, while he had parked his vehicle in nearby bushes.

Supt Kgosiemang said the police

swiftly responded to the report and indeed found his vehicle parked in the bushes but could not find him until he called them to come and get him at Sebina crossroads.

While on their way, they got another call from a passerby who informed them that someone had shot himself.

Supt Kgosiemang said on arrival at the scene, they realised it was the person they had been looking for. He said investigations into the incident are ongoing. BOPA

#### **NATIONAL SYMBOL**

#### Protocol of the National Anthem

- a) All should stand to attention with their hands placed on their sides while signing the National Anthem. Members of the armed forces and veterans who are present, but not in uniform, may render their military salute.
- b) When the National Anthem is being sung, members of the public should take their hats off as a sign of respect.
- c) The National Anthem is sung where dignitaries such as members of the Cabinet, Members of Parliament and the Chief Justice are on official duty.
- d) It has to be sung where dignitaries like His Excellency the President, His Honour the Vice President, Chiefs, and Ministers are on official duty and the Chief Justice inspecting the BDF parade.
- e) It has to be sung where the National teams are to represent the country and they are in Botswana colors
- f) The Botswana National Anthem is sung on all national activities that unite the nation as a symbol of patriotism and to mobilise the nation towards a common goal.
- g) It is important to note that, choirs assigned to lead the National Anthem at official events do not use vibratos because that distorts the National Anthem.
- h) Not to be used or recorded by musicians for entertainment neither nor on movies e.t.c by individuals and groups.
- i) It should not be translated to any other language without due consultation.
