

# **Minister implores** leadership to work harmoniously

**MOLEPOLOLE** - Kweneng and Letlhakeng district leaders have been urged to work in harmony as they are tasked with producing National Development Plan (NDP) 12 projects.

Addressing leaders included area MPs, councillors, Dikgosi and Village Development Committee (VDC) members in Molepolole on Wednesday, the Minister for State President Mr Moeti Mohwasa said working in unity would ensure they produce quality NDP 12 projects on time as bickering or arguments could only lead to unnecessary delay.

He asked the leaders to work with the National Planning Commission to plan for the country's next development agenda to take the nation forward.

He said this was not a political venture but a national project, which called for all stakeholders to be on board.

Minister Mohwasa also called for mindset change, saying the country failed to use previous NDPs to address issues of poverty and unemployment. He noted that it was unfortunate that the country enjoyed decades of opulence yet it was now faced with challenges at a time when the national purse had dwindled.

Mr Mohwasa said this meant everyone, not only politicians or public officers, have failed as the country, rich in natural resources, failed to accomplish the ideals of Vision 2016.

He said the next NDP should be people-centred and address unemployment and poverty. He said during their planning, they should envisage the Botswana they want to see in future, and not necessarily a country with best infrastructure with citizens living

Mr Mohwasa pointed out that Botswana, with a population of 2.4 million, should not be struggling with unemployment, poverty and poor health services.

He reminded politicians that after five years, they would have to present their performance plans to the electorate for evaluation.

He said as the Transitional National Development Plan ends in October, the NDP 12 should be implemented in November.

Mr Mohwasa advised that the general population should be consulted, saying the government bottom-up encouraged a development approach as the people knew and understood their issues better.

"Involve local communities in the planning process to align developments with their interests," he said. He said as politicians, they were there to offer political oversight and therefore appealed to them to seek expert advice from public officers. The minister reminded them to prioritise their projects as the country was facing financial constraints.

He said the councils should be empowered to come up with business initiatives, as they could not rely on government, adding that funds from the Constituency Community Projects (CCP) could be used for investment purposes.

He said this would help create revenue for councils, reduce unemployment and subsequently poverty levels would also decline. He said in the process, the councils would help generate the promised 500 000 jobs by 2029.

# Councillors prioritise key projects

**KANYE** - Kanye District political leadership will endorse water development, infrastructure maintenance, health facility development and environmental upkeep as actionable items for submission in the National Development Plan 12 (NDP 12).

This emerged at a special full council meeting held on Wednesday where councillors deliberated on key developmental issues to be included in NDP 12.

In an interview, the Deputy Secretary for Council Development and Planning, Mr Masilela Mandoze said the

council deliberations started with an overview of the plan looking at the Transitional National Development Plan projects.

He said that with the councillors' deliberations, some key local indicators were suggested to be included in NDP 12.

"Those were suggestions, which community members through the leadership deliberations had also indicated as core," he noted.

He said depending on the outcome, they would see from submissions made, which of the said projects would make it through as they were going to compete with others at national level. The other project reviewed

was the Ipelegeng programme Project Memorandum, which he said its enrolment in Kanye was at 2493 as per the reviewed quota of September 2024 and its budget was about P25.9 million.

"It reflects more focus on development and minor actors to be in the forefront of the maintenance works in the composition and identification district," he said. He also stated that there was the reviewing of Constituency Community Projects (CCP) guidelines, which came into effect in 2017 and stakeholders had suggested that due to time changes, the guidelines should be reviewed to avoid working with outdated

Furthermore, Mr Mandoze said members highlighted acceptance of the rest of the issues, except that they would like local leadership such as Kgosi, council members, Village Development MPs, Communities and other non-state of ward projects benefiting from

He said the other suggestion was of the P10 million threshold to be increased to P20 million for each constituency.

Mr Mandoze said the proposal was attributed to an increase of market prices as well as labour costs. BOPA

# Govt tackles tariff challenges

**GABORONE** - Government is intent on addressing challenges posed by the 37 per cent reciprocal tariff imposed on Botswana by the U.S.

The global tariffs have since been affecting international trade upon coming into effect on April 9.

Speaking during diamond stakeholders meeting held in collaboration with the Ministry of Labour and Home Affairs in Gaborone yesterday, Minister of Minerals and Energy, Ms Bogolo Kenewendo said the tariff issue was important as diamonds were the country's leading export.

"Our silence does not mean we are not acting. I am here to give you assurance that government is taking the matter seriously."

Ms Kenewendo said challenges emanating from the imposed tariff were not only affecting direct export channels, but also other markets the country was doing business with, such as India, Israel, Dubai, Antwerp and many others.

She said the concerned markets were being assessed to establish how the tariff had affected them and how they may be affecting the country's efforts of beneficiation.

"We are focused on this issue and engaging with the White House. President Advocate Duma Boko is actively working with a team to ensure that we have a proper strategy in attending to the matter and that the impact emanating from it will be mitigated accordingly. We intend to communicate with the industry regarding such efforts and we hope that in the meantime the diamond industry will remain steadfast, as it has shown in the past when exposed to various challenges."

She assured investors in the industry that government would persist in their engagement and keep them informed about President Boko's ongoing efforts.

She said since coming into effect the tariff was hitting hard on the country's economy.

Meanwhile, Ms Kenewendo said the meeting of the diamond industry players and Ministry of Labour and Home Affairs was a follow-up to the January stakeholder engagement, where it was proposed that the Diamond Hub should work toward becoming a true one stop shop and service diverse needs raised by players in the industry.

She said the labour ministry wanted to facilitate businesses in the diamond sector by ensuring their compliance with labour industry laws and regulations including those pertaining to visa applications, as well as work and resident permits. *BOPA* 

together and engineer measures to improve the work environment and welfare of employees.

Minister Mokgware said encounters with companies in the diamond industry showed some difficulties in establishing the office responsible for the wellbeing of the workers.

"When dealing with labour, we are tossed between the offices of the manager, human resource manager and director. We are left to wonder as to who is responsible for the well-being of employees," said Minister Mokgware.

He said government had in the near past engaged in labour inspections and diamond companies and businesses which were prompted by frequent complaints from employees.

He said most of the companies were found to be in violation of labour laws, with some encountering painful experiences and getting paid below the recommended mark.

"Some companies in the diamond industry are taking advantage of the desperate situation that the young people were found in as a result of unemployment.

They are subjected to exploitation, sexual harassment such as rape and other sexual violations," said the minister.

Maj. Gen. Mokgware said it

was important to work together to ensure that diamonds were a blessing to the workers of the industry.

"We exploit the people we are supposed to guide, grow and mould into responsible future leaders. Use of foul and abusive language was common with the industry" he said adding that the diamonds must not be used to hurt instead people who work in the industry must shine.

Minister Mokgware said some companies in the diamond did not provide their employees with medical aid cover, proper clothing suffering injuries that could have been avoided and being exposed to other health hazard.

He observed that most of the companies in the diamond business that were covered by the inspection did not have proper training plans, therefore making it difficult to even have a succession plan.

He said non-payment of workers who were subjected to work beyond the stipulated hours was one of the notable concerns.

Minister Mokgware added that the workers who were determined to fight for their rights were somehow eliminated from the system.

Minister Mokgware said the ministry was equally unsettled by the high numbers of employees that were retrenched by the companies in the diamond industry.

He said the labour inspection that was done in May-June 2023 had revealed that some 400 employees were retrenched under questionable circumstances with non-performance of the sector used as the primary reason for such an act.

Therefore, Minister Mokgware said companies must submit returns and audited financial statements to justify performance of the company.

He said in an effort to tighten the labour laws and address labour issues, he would during the winter Parliament table a bill for the amendment of the Labour and Employment Act, therefore appealing to all players in the diamond business to associate themselves with the draft document and provide their input.

He said another bill to be tabled would be on occupational health.

One of the ministry's mandate is to ensure productivity in the workplace and the minister said currently, productivity level in the country was at 0.44 per cent.

He said government was losing huge sums of money as a result of failure to comply with labour laws, adding that his ministry was to settle a debt of P123 million as a consequence of non-compliance with labour laws. *BOPA*

The donation comprised of literacy material and textbooks for primary, junior certificate and Botswana General Certificate of Secondary Education (BGCSE), as well as fiction and non-fiction books.

Receiving the donation in Gaborone yesterday, the Minister of Justice and Correctional Services, Mr Nelson Ramaotwana expressed delight that the donation came at a time when Botswana Prison Service was venturing into a transformational journey of being a Correctional Service.

He said the books would emphasise more on correcting the offenders by addressing the criminogenic tendencies that had driven them to commit crime.

"Books are not merely collections of words, they are doorways to new worlds, windows into our imaginations and tools for empowerment.

In a world where information is paramount, the ability to read and comprehend is a fundamental skill that unlocks countless opportunities," he said.

Mr Ramaotwana said literacy and access to knowledge had a profound impact on the lives of communities and the future, adding that reading also expanded one's knowledge and perspective through literature. The minister also noted that the books would reduce idleness, which could distract the prison service's to empower determination offenders for the betterment of their lives by maximising offenders' engagement in literacy and mind occupation.

He noted that once the inmates got engrossed in the books, they would not have the luxury of time to think of negative things that did not assist in their rehabilitation.

Minister Ramaotwana said the donation would also encourage other corporate organisations and individuals to share their resources.

"I have also learnt that the donation is a precursor to the signing of a memorandum of understanding between Macmillan Botswana and Botswana Prison Service, expressing hope that the partnership would be to the mutual benefit of the two institutions and ultimately to the nation," he noted.

Mr Ramaotwana implored Botswana Prison Service to jealously protect the integrity of the books by effecting strict control measures for their preservation. He also expressed gratitude to Macmillan for its commitment to fostering a love of reading and learning in the community.

"You've not only donated books, but you've shared hope, inspiration and the potential for brighter futures.

Your support exemplifies what can be accomplished when we work together for the common good," said the minister.

"May these books inspire curiosity, creativity and a lifelong love for learning. Let us create, in the offenders and ourselves, a community that values education and makes it accessible to everyone," he said.

Giving an overview of the initiative, Macmillan Education Botswana general manager, Mr

Kopano Sechele said access to books should not be a privilege, but a right. "Reading programmes should be integrated into broader rehabilitation efforts communication if we really want to empower Batswana," he said.

He also called for establishment and expansion of library programmes within correctional facilities to ensure inmates had access to a diverse range of books that catered to their individual needs and interests.

## Organisation vows to safeguard Okavango Basin

MAUN - Safeguarding the extraordinary Okavango Basin for future generations requires deep collaboration with communities, non-governmental organisations and government working together at every level.

The chief science and innovation officer from National Geographic Society, Mr Ian Miller made the remarks recently during the launch of Nkashi Knowledge Centre at Beetsha village.

He noted that their mission was to illuminate and protect the wonders of the world and cited Okavango Basin as one of the few magnificent wonders.

He said the society was an

important partner to advance the lasting impact. Mr Miller noted their commitment to investing in and supporting the National Geographic Okavango Wilderness project, which began a decade ago under the leadership of National Geographic explorer, Mr Steve Boves.

He said Mr Boyes had dedicated his life to conserving Africa's wilderness areas and the species that they depended upon through innovative and integrative methods.

Mr Miller said in 2015, Mr Boyes launched the Okavango Wilderness project, a multi-year effort aimed at exploring and protecting the little known wilderness of the Angolan highlands.

This is the one, he said, that

provided 95 percent of the water that sustained the delta and the biodiversity of the greater Kavango-Zambezi Transfrontier Area and the project had now become the National Geographic Okavango Wilderness project.

"Today Mr Boyes works alongside eight explorers from the region. Collectively, they are combining science with traditional knowledge, exploration, education and powerful storytelling to help ensure the future of the Okavango," he added.

Mr Miller appreciated that a partner, De Beers Group emerged four years ago to supercharge their efforts through partnership with Okavango Eternal and they had already seen tremendous progress.

He said they had made significant advance in science research, citing a job well done by the Okavango Wilderness Project team, which had mapped more than 1.25 million hectares of critical Angolan habitat, prioritising the area for conservation.

"Just as important, have worked closely with the communities to ensure they are leading the way in conservation. Together with De Beers and other stakeholders, we have helped create more than 1500 opportunities from bee-keeping to regenerate agriculture, basket weaving and entrepreneurial skill building," he said. Mr Miller said another meaningful outcome of their partnership saw the word 'Nkashi' evolve, citing that what began with the Nkashi Classic and the National Geographic Film about the mokoro race had become a movement.

Many, he said, had shared how 'Nkashi' now stands for forward momentum, resilience and a hopeful future for the Okavango.

He added that the movement came to life with the flagship Nkashi Knowledge Centre in Maun, a thriving hub that had already welcomed more than 3000 students, scientists and community members for trainings, events and learning opportunities.

He said through the centre, they had engaged hundreds of youth in Science, Technology, Engineering and Mathematics (STEM) as well as conservation initiatives through a new laboratory and also helped them and young professionals refine how they tell their stories through storytelling clubs.

"With the launching of Beetsha Centre, we are accelerating these efforts again in the heart of the delta and it is our hope that this space opens doors in ways that continue to elevate this community to build upon skills and reinvest them here to become the next conservation leaders, educators, storytellers and mentors," he added. BOPA

With this era of technological evolution, Prof Norris said institutions of higher learning curricula should meet the needs of this increasingly digital and globalised world.

"Information management today focus on advanced data technologies including big data, cloud computing and artificial intelligence (AI)," he said, adding that information systems were designed for real time data processing. Therefore, Prof Norris said there was a strong emphasis on data and analytics as well as data mining and machine learning.

"The curriculum incorporates Norris.

Moreover, he said with countries currently talking knowledge economies, it was for African institutions of higher learning to also be at par. He said countries needed

well-educated, well-trained and highly skilled people to generate, distribute and use information and knowledge. "The knowledge economy depends on effective policies and economic environment that promotes entrepreneurship, stimulates investment information and communication technology and permits the free flow of knowledge," Prof Norris

Meanwhile, Prof Tom Kwanya of Technical University of Kenya said stakeholders should embrace AI, but said it needed context and ethics. He said librarians and information professionals were uniquely placed to bridge the gap between communities and technology.

He said knowledge systems should be reliable and sustainable tools, which can withstand shocks, adapt to change and continue to serve the people who rely on them.

"We are living through a time of enormous disruption from climate change and pandemics to disinformation and digital inequality and the world is testing the limits of the systems we depend on to make sense of it," said Prof Kwanya.

He added that knowledge systems such as libraries, archives, universities and data repositories were under pressure to be more adaptive, inclusive and secure.

He said knowledge should be inclusive, empowering and harmonious with AI and said the next generation of knowledge systems should be passive users of AI.

Held under the theme: Strengthening Information and Knowledge Management Paradigmmes in the Era of Advanced Technologies, the conference has drawn participants from various institutions of learning across Africa such as Botswana, Nigeria, Zimbabwe, South Africa and Kenya among others. BOPA

# Learners to benefit from collaboration

GABORONE - In a landmark move to promote environmental education in Botswana, Children in the Wilderness (CITW), Botswana Insurance Holdings Limited (BIHL) Trust, and Mokolodi Nature Reserve have signed a Memorandum of Understanding (MoU) at Tshwaragano Primary School in Gaborone on Tuesday.

The three-year tripartite collaboration, supported by a P220 000 investment from BIHL Trust, aims to instill environmental awareness in young learners, blending theoretical knowledge with hands-on conservation experiences.

This initiative builds on BIHL Trust's long-standing commitment to supporting education, with Tshwaragano Primary School forming part of its Adopt-A-School programme.

"At BIHL Trust, we believe that investing in youth education and empowerment is the most sustainable way to ensure long-term conservation," said BIHL Trust Board chairperson, Ng watshi Enyatseng. "This programme reflects our commitment to building resilient communities and nurturing a generation that values and protects our natural heritage," he added.

She emphasised that conservation was not the responsibility of scientists alone. "It starts with our children, and with partnerships like this, we can catch them early," he noted.

The CITW programme, an initiative of Okavango Wilderness Safaris (OWS), brings extensive experience in youth engagement

through environmental education, life skills development, and leadership training.

Tshwaragano Primary School is the latest urban school to join the CITW programme and has shown remarkable engagement in environmental initiatives. "We've had an especially strong collaboration with Tshwaragano Primary School more than with many of our rural partner schools," said CITW Board member, Derek de la Harpe. "Our mission is to educate, inspire, and uplift children through a programme that aligns with the national education syllabus, especially in subjects like Agriculture, Science, and Social Studies," he stated.

While Tshwaragano learners have previously attended CITW's annual educational camps hosted at OWS lodges, the school's urban location has posed challenges for consistent access to nature-based learning. This new partnership addresses that gap by incorporating Mokolodi Nature Reserve's natural environment.

"Mokolodi is committed to nurturing the future custodians of Botswana's natural heritage," said Dennis Ramokgau, Education and Stakeholder Manager at Mokolodi.

The initiative will include teacher training workshops to strengthen capacity in environmental education, 23 Eco-Club sessions per year aligned with the academic calendar, practical excursions to Mokolodi, and student-led projects with entrepreneurial potential. CITW's annual camps will also continue, offering a platform for leadership development and celebration of learning. *BOPA*

# Relocation of health services addresses quality provision

**BEETSHA** - The relocation of primary health services to local councils is a step in the right direction to turn around the healthcare system by addressing issues that compromised quality health care provision.

Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa made these remarks during a recent tour of Beetsha clinic to appreciate challenges faced by employees.

He noted that they believed the councils could do much better to ensure communities access health services closer as well as attend to challenges well on time.

As such, he urged employees to be inspired, as the councils

would take the responsibility to ensure health facilities are well resourced to motivate them to produce quality results.

He said well-resourced workplaces could stimulate an environment that enhanced productivity and job satisfaction, leading to increased overall performance.

Mr Motshegwa assured employees that challenges such as shortage of resources and staff would be prioritised and encouraged them to work as a unit, saying the government recognised their efforts towards saving lives and promoting healthy lifestyles.

The nurse in charge at the clinic, Mr Walter Ovoya informed the minister and his entourage that the clinic was faced with a serious shortage of staff, citing that 50 percent of staff was hired on temporary basis.

He said six nurses manned the clinic, one was a midwife nurse who served three clinics of Gudigwa, Beetsha and Eretsha, noting that transport was also a serious challenge as their catchment area was vast.

During weekends, he said one nurse on duty had to man all the three clinics and thus compromised delivery of quality health services to the communities.

"Currently, we are in a malaria season and we are overwhelmed as we have to see on average, more than 100 patients seeking health services in a day," he added. **BOPA** 

## Lentswelemoriti land issue sparks verbal war

- The verbal war that has been simmering for some time concerning developments within the St. Engenas Zion Christian Church private land dubbed Lentswelemoriti, has attained full maturity, at least by observation and confirmation.

The kgotla meeting by area Member of Parliament, Mr Taolo Lucas was a catalyst that ignited a spark for the all-out, no holds barred verbal war between messengers of the church led by St. Engenas ZCC's chairperson of the church council, Mr Piet Lekganyane and residents of Lentswelemoriti.

Clearly, the two parties have been engaging unsuccessfully to a point where a group dubbed 'Bana ba Letswelemoriti' paid MP Lucas a visit to try and intervene with a view of hatching a lasting solution between them and the private land owner, being the church.

At the centre of the war is

the fencing of the farm which Mr Lekganyane said was for the security of the people living within the farm, a claim vehemently objected to by the 'Bana ba Lentswelemoriti.'

In erecting the said fence,

not to have been consulted upon which they were disrespected for voicing out their displeasure.

They claim that the fence is, in

They claim that the fence is, in some instances, too close to their yards and therefore becoming "a death trap".

They argued that as Batswana who should be enjoying their full rights, they needed not be fenced and or contained as they had co-existed with wild animals ever since 1953 when they landed from Mochudi, where they fled religious persecution.

They alleged that Mr Lekganyane and his entourage would dismiss them as "nothing" and asked who they were when they aired their grievances. Mr Lekganyane did not rebut the claim, but said they regretted nothing at all.

"We can't be demonized and dehumanized in this only land we call home.

We have the minutes of our meeting with the bishop where he promised us that no developments will be carried here without consulting us," Mr Batshidi Tsae

"We seek church leaders to respect us and we will in turn offer the same as this 'village' is synonymous with mutual respect," Ms Sylvia Mlauzi said.

While they demanded respect, they were reminded of the rights of the freehold land owner in the private land they were demanding respect while lodged at.

However, Mr Lekganyane was unapologetic about the church fencing the area and telling those who seek developments to leave the farm and resettle elsewhere.

"When their parents fled Mochudi over religious persecution, the bishop granted them temporary stay in this private farm until the time when things got normal again. But as you know people, they took

advantage of the whole situation as if they're now in their land," said Mr. Lekganyane.

He said that during the said meeting where they claimed disrespect, they flatly refused to sign attendance register when he had requested to and as a result he decided against going on with the meeting.

Mr Lekganyane said the Bana Ba Lentswelemoriti committee did not have the authority to meet with MP Lucas over a church

He said the ringleaders, who provided statistics of who preferred to stay not to stay in the farm inter alia, did not stay in the 'village' but elsewhere and hence they failed to turn up to the consultative meeting they were invited to despite having been given a week to prepare.

The chairperson of the church council pleaded with the complainants not to force the church to implement stiffer rules in order to keep them in line.

"We could start with lease agreement for each and every

house inside here if you want to force us into that direction," he

While in full understanding and agreement with church leadership over running of their private land, MP Lucas pleaded for courtesy in engaging with residents.

"While accepting that this is a private land we must also acknowledge that there are people living on it already," said Mr Lucas, while also conceding that Mr Lekganyane was right in claiming that only the land owner could dictate what happens in their farm.

He appealed to church leaders to be clear on whether or not they intended on evicting the people from the farm, and if so, to provide timelines for people to thoroughly prepare.

Realizing that the residents were emotionally charged, the MP encouraged them to appreciate the realities obtaining at the farm as freehold farms were constitutionally provided for.

# **BURS** surpasses revenue target

**GABORONE** - Botswana Unified Revenue Service (BURS) has exceeded its revenue target for the 2024/25 financial year, collecting a record P61.097 billion in net tax revenue, surpassing the goal of P58.704 billion.

This achievement, marking a 4.08 per cent overachievement, is the highest in BURS's history.

At a press briefing in Gaborone yesterday, BURS Commissioner General, Ms Jeanette Makgolo, attributed the success to effective strategy, institutional commitment and national collaboration.

However, she acknowledged the challenging economic environment, which saw a 3 per cent decline in the country's GDP in 2024, highlighting the critical importance of domestic resource mobilisation.

Ms Makgolo explained that the surplus was largely driven by strong performances in Value Added Tax (VAT) and Southern African Customs Union (SACU) receipts.

"VAT exceeded its target by 28.15 per cent, collecting P14.455 billion compared to the projected P11.280 billion while SACU receipts also surpassed expectations, reaching P27.566 billion, P855 million above the target," she said.

Ms Makgolo credited the VAT success to resilient domestic consumption and SACU's positive performance to favourable exchange rates.

However, Income Tax collections fell short by P1.745 billion, with P18.968 billion collected against a target of P20.714 billion. This shortfall, she said was attributed to challenges in the mining sector, including declining global demand for diamonds, unfavourable prices, stockpiling by dealers as well as subdued domestic business profits.

Ms Makgolo said BURS's Strategic Plan for 2024–2029 aims to mobilise P120 billion by March 2029 through diversification and modernisation of tax collection mechanisms.

The plan, she said, focused on closing tax gaps, improving compliance and introducing new revenue streams.

"Despite the economic downturn, we could not afford to sit back," she said, stressing the proactive approach through interventions like the creation of oversight bodies such as the Revenue Management Committee and Revenue Collection War Room.

BURS also launched the Multi-Disciplinary Block Management

Unit to inspect businesses nationwide for tax compliance, particularly targeting the cash economy. She said the agency also intensified its efforts with physical inspections at borders and airports, along with deploying anti-smuggling teams.

Additionally, mobile tax units were introduced to deliver services and educate taxpayers in remote areas

As the 2025/26 financial year approaches, BURS faces a new target of P60.475 billion. To meet this goal, she said BURS plans to implement further reforms, including the introduction of a track-and-trace system for excisable goods, a transit monitoring system to prevent dumping and an electronic VAT invoicing system. BURS also intends to introduce VAT on

digital platforms, a significant step to bring the growing digital economy into the tax net and expanded taxpayer education will also play a critical role in improving compliance.

Beyond revenue collection, Ms Makgolo said BURS also played an important role in facilitating trade.


The Authorised Economic Operator (AEO) programme, launched in 2023, offered preferential treatment to compliant traders. To date, she said five businesses had been accredited, with three more pending. Ms Makgolo explained that the programme accelerated customs procedures and incentivised tax compliance.

Meanwhile, Dr Lesedi Senatla, Chairperson of the BURS Board, stressed on the strategic importance of revenue collection in the current economic climate.

Dr Senatla highlighted that BURS's role was not only essential for financing the national budget but also for managing borders and facilitating trade.

He said the agency's ability to exceed revenue targets, despite economic challenges, provides crucial funding for social programmes.

Looking ahead, Dr Senatla reiterated the government's commitment to expanding the domestic tax base, with BURS tasked with collecting over P60 billion in the current financial year. He also shed light on ongoing efforts to improve operational efficiency, including the review of key tax legislation and the taxation of digital platforms. *BOPA*

# Namibia urges African countries to boost electricity production

WINDHOEK - Namibia has called on African countries to stop relying on imported electricity and instead invest in local renewable energy to strengthen energy independence.

Speaking at the opening of the Regional Energy Regulators Association conference in Swakopmund on Wednesday, Deputy Prime Minister and Minister of Industries, Mines and Energy Natangue Ithete said the region was facing rising electricity costs and unstable power supply, which

was affecting ordinary people and economies.

"The long-term solution lies in bold, coordinated action, such as investing in domestic renewable energy generation, strengthening transmission and storage infrastructure, and creating a regulatory environment that attracts private investment while protecting the vulnerable," he said.

Ithete said inclusive access to electricity must be a priority for both rural and urban communities. He called for stronger regional cooperation in harmonising energy regulations, sharing resources, and building interconnected electricity markets.

"We must take action now to ensure energy for all and reduce our dependence on outside sources," he said.

The deputy prime minister urged regulators to return to their countries with clear action plans, realistic local electricity production targets, and policies that ensure affordability and sustainability. *Xinhua*

## Stock theft syndicates terrorise residents

MAUN - Stakeholders have been urged to join forces toward cracking down stock theft syndicates in the North West District.

Despite efforts by the government to establish a stock theft unit in the region, the area is experiencing a rise in stock theft, which had led to some kraals abandoned while some residents are living in fear of losing their livestock.

Kgosi Tapoloso Mosika of Lekawa Kgotla in Maun said during a meeting with the district leadership on Wednesday that the thieves were armed with dangerous weapons. He implored government to tighten laws and stiffen sentences, to deter criminals from engaging in such crime.

He revealed that there were some cattle posts in the outskirts of Matsaudi termed as 'no go area' because they served as a haven for stock theft syndicates.

"The thieves are denying communities the right to enjoy their wealth" said the concerned Kgosi Mosika, who also indicated that his kraal was empty because of stock theft.

He also cited a recent incident in which 10 goats belonging to a certain farmer were stolen and kept in a hole in the bush.

He said it seemed the culprits monitored the movement of farmers noting that his animals were stolen while he was away in Maun for health reasons and upon return the following day, he found the kraal empty.

Kgosi Mosika also raised concern over butchery owners who

patronised such culprits by buying cattle and slaughtering them in the

He indicated that there were reports that the stolen meat was sold to some local butcheries in Maun.

He said, the issue was of concern to traditional leaders under Matlapana customary court as farmers were using Topline dip aimed to control bovinedermatophilosis disease, which they had been informed that it lasted for a period of three months in an animal.

"Our concern is that members of

the community's health is at risk as they may end up buying the meat that is unsafe for consumption."

While he appreciated efforts by the police to curb the problem, he emphasised they could not win the battle alone as they were under resourced and pleaded with other key stakeholders and the community at large to support

Stock theft, he said, had broader social and economic implications, which could impact the entire rural community and the wider agricultural industry hence the need to act to curb it.

Kgosi Mosika also highlighted that some thieves kept matimela cattle in their kraals, allowing them to give birth and then brand and mark the calves as their own.

traffic Division officer. Senior Superintendent Emisang Makgasane, shared the same sentiments saying stock theft was a problem countrywide. He however, stressed the need to strengthen community policing and rapport with police to combat the vice.

She highlighted that the situation was exacerbated by some farmers as they let their livestock roam freely without branding and

or a mark saying thieves took advantage, hence she called on farmers to introspect and brand their animalds to fend off the thieves. Farmers were also advised to ear-tag their calves as a way of fighting stock theft. She said livestock was the backbone of many rural communities and if the situation was not arrested, it would leave some farmers impoverished.

Senior Superintendent Makgasane encouraged residents to report any suspicious incidents of stock theft to help police address the problem and bring the culprits to book. BOPA



# Ngwanathebe breaks barriers

**MAUBELO** - In a society where certain industries are often perceived as maledominated, Tumisang Ngwanathebe is carving a niche for herself in the world of leather.

As the founder of Skin and Things Consultancy, she is not just creating exquisite leather products; she embodies determination, perseverance, and a commitment to sustainability, all while empowering others and proving that gender should not dictate success.

Ngwanathebe's journey began in 2010, inspired by her parents' involvement in leather tanning and processing.

Growing up in a family that worked with

leather, she developed a deep appreciation for its potential. "I realised that leather can be the second diamond of Botswana," she said, highlighting the resource's untapped value

She produces a diverse array of goods, including corporate gift bags, wine bags, knife pouches, belts, traditional mats, flowerpots, and hats.

Not only do her creations highlight the beauty and versatility of leather, but they also contribute significantly to the local economy.

Her commitment to environmentally friendly practices sets her apart in the industry.

Ngwanathebe sources hides and skins from local butcheries, weddings, and even funerals, often acquiring them at no cost. This method not only reduces waste but also creates a unique and eco-friendly resource for her creations.

She skillfully transforms hides from goats, sheep, cows, camels, and even wild animals like lions and cheetahs into finished goods, showcasing her extensive material expertise.

The transformation from raw hide to finished product is a meticulous and sustainable process.

Ngwanathebe incorporates natural resources such as Zutshwa salt, lime

(kalaka), and the Elephantina plant (mositshane) while using herbs to produce different colours. "I use hand tools for crafting my work because they are more durable compared to machine work," she explains.

Despite her a c c o m p l i s h m e n t s,

Ngwanathebe admits she faces challenges, including a lack of market, limited

skilled manpower, transportation costs for harvesting herbs and collecting hides, equipment costs, and financial constraints. She also encounters difficulties with improperly skinned hides from some suppliers.

Her expertise has gained national and international recognition; she trained with the Botswana Training Authority (BOTA) as a trainer and assessor.

Her accolades include winning first prize at the 2010 Botswana Consumer Fair, where she competed with other SADC countries and earned the Local Manufacturing Award.

More recently, in 2023, she received the 1st Prize at the Global Expo - Productivity Award, again among SADC countries.

Beyond her entrepreneurial success, Ngwanathebe is dedicated to uplifting her community by offering training in leather tanning and product creation.

Her advice to women is, 'Women should no longer think there are male-dominated fields."

She also emphasises the importance of patience and determination in business. Her journey serves as a reminder that with passion, perseverance and respect for the environment and community, anything is possible. *BOPA*
