'Modernised police service essential'

GABORONE - A highly modernised and agile police service is vital to ensuring law and order says Assistant Minister of Communication and Innovation, Mr Shawn Ntlhaile.

Speaking at the handover ceremony of the refurbished Phakalane Police Post in Gaborone on Tuesday, Mr Ntlhaile emphasised the importance of creating an environment where all Batswana can enjoy basic human rights, including the right to life, education, shelter, and clean water, as outlined in United Nations Conventions.

"The government must address the persistent and alarming levels of violence, particularly in relation to crimes such as gender-based violence, which are often exacerbated by drug use," Ntlhaile explained.

Mr Ntlhaile who is also the Member of Parliament for Gaborone North, stressed the significance of upholding human rights while maintaining the rule of law to build a better future for Botswana.

He acknowledged the Botswana Police Service's ongoing efforts to ensure the safety and security of citizens and their property, highlighting their capabilities in tackling contemporary crimes, including cybercrime, human trafficking, money laundering, and terrorism financing.

He assured that the government would continue to allocate resources equitably towards high-yield projects and programs for the benefit of the broader population.

The Commissioner of the Botswana Police Service, Ms Dinah Marathe, addressed the challenges of urban crime, particularly in Phakalane, noting a rise in property break-ins, home invasions, and vehicle thefts targeting unsuspecting citizens. She confirmed that strategies are being implemented to combat these issues and ensure a safer environment for residents.

Ms Marathe stressed the importance of equipping the Botswana Police Service with modern resources and facilities that meet the expectations of the community.

"Despite current economic challenges, we are grateful for the resources available to us. We commit to the optimal utilisation of the scarce resources we have for the greater benefit of Batswana and residents, said Ms Marathe.

However, Ms Marathe noted that many police facilities were aging and have surpassed their maintenance cycles due to financial constraints, which could impact officer morale and public interactions.

"The current state of facilities underscores the need

for alternative maintenance solutions," she warned.

The Commissioner highlighted the 'Adopt-a-Police-Station' initiative, which fosters a partnership between the Botswana Police Service and the business community.

This initiative represents crucial investments in policing infrastructure and corporate social responsibility.

"This collaboration not only enhances the physical appearance of police stations but also strengthens our law enforcement capabilities," Ms Marathe said, committing to the continued development of this strategic partnership for mutual benefit. *BOPA*

ICT remains key to economic growth

MAHALAPYE - Data and technology remain the key drivers of thriving economies. Thus, investing in this dynamic problem-solving and innovation platform would guide Botswana's economy towards swift growth and success.

This was said by the Minister of Communications and Innovation, Mr David Tshere, while giving a keynote speech at the Mahalapye ICT Leaders Convention themed: Creating the ICT Roadmap for the Next Five Years.

He also emphasised that involving stakeholders from both government and the private sector in creating the ICT roadmap for the next five years sought to make certain that all technology sectors were addressed to act as a guide for growth, inclusivity, and sustainability.

Likewise, he highlighted that innovation and productivity were enhanced through partnerships.

He urged multiple sectors to collaborate in creating a plan that focused on digital infrastructure and connectivity, enhancing capacity and skills, along with offering support for innovation, entrepreneurship, and policy development. "As leaders, we should not just adopt new technologies like quantum computing, blockchain, and the Internet of Things; we need to spearhead their integration into daily life, fostering efficiency, sustainability, and advancement," he added.

Mr Tshere highlighted that although technology, especially Artificial Intelligence (AI), provides solutions and simplified tasks for all, ethical and responsible utilisation must always be maintained.

"As we adopt Artificial

Intelligence, make decisions based on data, and automate government services, we must guarantee that our progress maintains privacy, security, and ethical principles.

Advancement should not occur at the cost of essential human rights and principles, he said.

For his part, CEO of the Botswana Communications Regulatory Authority (BOCRA), Mr Martin Mokgware, mentioned that BOCRA's role as a regulatory agency was to ensure adherence to laws concerning communications and data.

He noted that to draw tech investors, Botswana must reassess its technology and communications regulations to establish a favourable atmosphere for business activities and implement strict measures to protect users from cyber attacks.

Additionally, he urged both individuals and businesses to become acquainted with regulations related to information, communication, and technology, like the Data Protection Act, to prevent ending up on the wrong side of the law.

Business Botswana president, Mr Neo Nwako, advocated for automating the government procurement system, stating that it would provide all vendors an equal opportunity and assist in eliminating corruption.

He stated that the system would enhance efficiency and productivity for both governmental entities and businesses.

Additionally, he recommended investing in the upskilling of existing ICT graduates to address the deficiency caused by the shortage of skilled workers capable of managing technical issues related to emerging technologies, which frequently results in outsourcing jobs overseas, an approach that proves costly for all businesses. *BOPA*

Government to equip police with advanced technology - Boko

KGAGODI - Government will soon equip the police with advanced technology, including drones aimed at enhancing crime-fighting efforts.

The multifaceted uses of drones will assist in surveillance and monitoring operations.

"Drones can be deployed for various purposes, such as locating criminal activities both day and night, conducting investigations, and monitoring borderlines," President Advocate Duma Boko explained during a kgotla meeting in Kgagodi on Tuesday.

Emphasising the need for the police to adapt to modern technology, President Boko stated that its implementation would enable law enforcement to work more efficiently for the benefit of residents.

He expressed confidence in the skills and capabilities of the Botswana Police Service, stating, 'the use of drones can significantly simplify their duties.'

Addressing the rising crime rates, the President reiterated government's responsibility to safeguard citizens.

"Every individual should feel safe regardless of their location, and it is the duty of the government to ensure their protection. The integration of drones into policing will enhance public safety," he affirmed.

The aerial advantages provided by drones, as noted by President Boko, would offer police officers a comprehensive perspective during operations.

He referenced successful past incidents where police cameras installed in certain regions have led to the apprehension of criminals, indicating a positive shift towards more effective policing.

Moreover, President Boko informed the community that the government was currently

negotiating with international drone suppliers to expand the range of available technology within the country.

On other matters, President Boko emphasised the commitment to human rights, assuring residents that their rights would not be compromised under his administration.

"It is the government's duty to meet the needs of its people, and they should not feel that assistance is an act of favouritism," he said.

The President urged citizens to remain hopeful as the government continued to work towards fulfilling its promises and achieving prosperity for the nation

He said government was committed to paying pensioners P1 800 monthly, stating, "while the current allowance stands at P1 400, I am optimistic that this will soon be adjusted to P1 800 as part of our dedication to supporting our elderly," he said.

PNR to open mines, promises job creation

SELEBI PHIKWE - Premium Nickel Resources (PNR), a Canadian firm that acquired both Selebi and Selebi North mine shafts, will eventually open for operations, President Advocate Duma Boko has told residents of Selebi Phikwe.

Addressing the residents at Sam Sono Stadium, Tuesday, President Boko, although noncommittal to time frames, said government was encouraging and gently pushing PNR to expedite opening of the two shafts in order to help ease off the dire need for jobs.

"Will the mine ever open? Selebi, Selebi North, yes, PNR who acquired them, will open," said President Advocate Boko.

"We want people to work, but we're not focused only on the mine... We should resuscitate the economy of Selebi Phikwe by all means necessary and possible," Advocate Boko added.

The President said there was a logistics company looking to invest P200 million in the copper/nickel mining town, a move that would

create jobs in a town that used to look like a graveyard following the closure of BCL Mine back in 2016.

Consequently, the Ministry of Minerals and Energy, through department of mines, has approached the liquidator with a view of acquiring the houses in question through the credit facility the liquidator acquired at the beginning of the liquidation process

Although the amount was not stated, the liquidator was to reimburse government upon successful sale of the BCL Mine.

The houses would then become property of government after which the residents would be engaged on a way forward, the President said.

Not only was the liquidator evicting tenants from the BCL houses, he ensured that the state-of-the-art smelter was stripped and sold as scrap metal, the President said

The President alluded that the BCL Mine was sold without thorough knowledge of the amount of minerals available underground and hence the new owners could not believe their luck post exploration when they found huge deposits of copper and nickel at their acquired shafts. Government tried to hatch ways to remedy this, but the liquidator's actions were legal and above board, the President found.

Resultantly, the President, with a team of experts and advocates, put heads together to 'sweat blood' until the only available avenue was the Presidential Commission of Inquiry, which could lead to the unearthing of the truth behind the liquidation of BCL Mine.

The said Presidential Commission of Inquiry is expected to kick-off mid-June. At the end, there will be actions to be taken following the recommendations of the commission of inquiry, Advocate Boko said.

The President said that some people may end up facing the law if implicated while those who enriched themselves through the process may find the products of such enrichment confiscated.

The liquidation of the BCL, President Boko said, was a result of

reckless and grave decision by the then government to go against his free counsel in parliament whilst still a Member of Parliament for Bonnington North in 2016.

Advocate Boko said that upon realising that the then Botswana Democratic Party-led government intransigently ignored his counsel against liquidation of the BCL Mine, he then offered that the government adopted judicial management, which they, too, turned a deaf ear to.

With the judicial management, President Boko said government could have had some power and control as opposed to liquidation where all the power was vested on the liquidator, leaving the government, the major creditor, powerless.

By opting for liquidation, President Boko said that the then government's action was akin to locking themselves outside a house and then throwing keys inside the house where sits the liquidator.

Upon being faced by a hailstorm the same government would then beg for the liquidator to let them in, but would turn them down.

To rid uninformed decisions, Advocate Boko said that leaders needed to engage in rigorous pondering over the decisions they were to make and their possible ramifications on the lives of the people. Before then, the President said the liquidator had gone to government to be allowed over six years for a successful liquidation process where he would prepare the mine for a profitable sale.

It is reported that the then government declined the request and forced the liquidator out under the guise that he was failing the process. The closure of BCL, a mine that provided for about 5 000 direct employees and tens of thousands indirect beneficiaries, saw some people lose their lives over the burden of shouldering responsibilities of providing and caring for their families whilst unemployed, Adv. Boko said.

In closing the mine abruptly, the President said, the rights of the workers inter alia were trampled upon. *BOPA*

TVET allowance increase August

LERALA - Living allowances for Technical and Vocational Education Training (TVET) students, will be increased from the longstanding P300 to P1 900 effective August.

President Advocate Duma Boko said this when addressing a kgotla meeting in Lerala yesterday.

President Boko highlighted the significant disparity between the financial support provided to TVET students and that offered to their peers in traditional tertiary education.

He pointed out that the current funding structure often demotivated potential learners from pursuing valuable skill-based jobs, perpetuating the stigma that technical education was only for those who struggled academically, hence the need for a re-evaluation.

"The disparity has created a negative narrative about technical education, as a last resort for those who do not thrive academically. This perception is not only a misinformation but also counterproductive to the growth of handy skilled expertise, as it

discourages youth from acquiring essential skills in fields that are in demand," he said.

Furthermore, the President said handy skill courses, which included plumbing, bricklaying, electrical work and automotive repairs, amongst others, were crucial for the country's infrastructure and innovative capabilities, adding that an increase in living allowance would instil pride in hands-on skills as a means for personal and professional success.

President Boko also encouraged the continuous need for a holistic educational approach that goes beyond traditional metrics of academic success, fostering creativity and practical skills.

He said the world was increasingly defined by values of diverse skills and the intelligence of the multifaceted, therefore diverse skills that include creativity and other non-academic excellence were relevant to shape the desired future.

President Boko acknowledged concerns raised by Kgosi Molebatsi Moroka III, regarding the escalating crime in the village.

He said a decision was made to construct a police station that would house seven police officers, which was currently at 35 per cent completion and it was expected to be handed over next year January.

President Boko further said more accommodation structures would be added to accommodate two more police officers.

Kgosi Moroka III had also pleaded with the government to protect Bogosi from political interference, saying it crippled the essence of Bogosi, and made it difficult for Dikgosi to fulfill their duties of instilling peace, harmony and safeguarding traditions amongst others.

He further urged the need to elevate the status of Bogosi to make it relevant and match the current demands. *BOPA*

Residents call for end to injustice

KAUDWANE - The Kaudwane community has called for the end of injustice they have endured since relocation from their ancestral land.

During an inter-ministerial committee consultation meeting held in Kaudwane on Monday, many community members who took to the podium stated that the relocation had perpetuated marginalisation of Basarwa.

They stated that they have been informed that they reside in a wildlife management area, which prevents them from being allocated land for farming and boreholes in Kaudwane, yet there are some boreholes owned by individuals who do not reside in Kaudwane.

They also accused the government of failing to fulfill the commitments made when relocating the Basarwa from the

Central Kalahari Game Reserve (CKGR).

They expressed that everything promised by the government had turned out to be an illusion up to this point, and the government has brought more suffering than benefits from their relocation from the CKGR.

Mr George Pihelo, who was the first to take to the podium, called for a review of the Constitution to acknowledge the Basarwa, stating that they have suffered oppression for an extended period.

He cited the case of Mr Pitseng, who remained in the mortuary for years, as clear evidence of how the previous administration disregarded the rights of the Basarwa.

He insisted that the government had failed to fulfill the promises made during their relocation from their ancestral land.

He stated that they should be

returned to the CKGR and he emphasised their desire to be buried there. Ms Kebatshabile Moloreng warned the commission to deliver their recommendations as soon as possible, failing which they would take their property and return to the CKGR on their own.

She noted that the Basarwa community suffers greatly from a lack of employment, highlighting that even graduates from tertiary institutions remain unemployed. She stated that the government had failed to fulfill the promises made during their relocation, and they are having difficulty accessing basic services from the government.

Ms Kebafilwe Sebopego shared that their relocation was poorly managed, resulting in the loss of their belongings, including livestock, during the process.

He remarked that living in Kaudwane feels akin to living in

hell or being imprisoned.

Mr Bompone Chelete said the land board said they could not be allocated land for farming because they are living in a wildlife management area.

MrThobokwe Selelabongwaka, who called for a constitutional review, requested relocation back to the CKGR and the provision of farms within that area.

Mr Pogiso Ithuteng stated that they are not allocated land for farming due to their designation within a wildlife management area. Ms Gabaakelwe Pihelo noted that the affirmative action frameworks have not benefited the Basarwa people.

Mr Keotshabetse Ithuteng expressed a desire to return to the CKGR to enjoy their freedom, saying that Kaudwane lacks land for cultivation. He suggested that essential services, such as schools, should be established in the CKGR.

Mr Gaboemelwe Ramaeba emphasised that the Basarwa are aware of their heritage and can guide the government in this regard.

However, he cautioned that the

relocation process to the CKGR should be handled carefully to avoid further complications. Concerning special hunting permits, he argued that they should be granted to Basarwa, but only under specific conditions.

He lamented that unlike in the past, many people now hunt for commercial reasons rather than for sustenance.

He also requested the allocation of borehole points in Kaudwane and the repair of the CKGR fence to protect their livestock from predators, while waiting for a sustainable solution.

He said there are some borehole owned by individuals who do not reside in Kaudwane.

The area councilor, Mr Solly Phetogo highlighted the need for health services in Kaudwane.

Earlier, the commission's representative who is the permanent secretary in the Ministry of Transport and Infrastructure, Mr Kgakagamalo Ketshajwang, noted that in previous consultative meetings it emerged that the rights of the Basarwa, particularly those of children, were neglected. *BOPA*

Take advantage of debt amnesty to reduce arrears - MP

MORWAMOSU - Morwamosu residents have been urged to take advantage of the Water Utilities Corporation (WUC) debt amnesty initiative which gives domestic customers a 50 per cent discount on their water bills.

The campaign, which runs from April 1 to June 30, allows eligible customers to clear the remaining half of the debt within the three months.

Speaking in a kgotla meeting addressed by the Member of Parliament (MP) for Jwaneng/Mabutsane, Mr Omphemetse Kwapa in Morwamosu on Monday, WUC Mabutsane subcluster supervisor, Ms Arona Epadile implored residents to apply for debt amnesty assessment and make payment plans towards the remaining bills within the stipulated period. She noted that the amnesty only applied to old debts that were over 90 days old, while new debts would be billed

the usual way.

"You are encouraged to go and register for assessment of your bills and make payment plans for the remaining 50 per cent. If you fail to pay within the three months your debt will be billed as usual. You must also understand that this campaign only targets debts that are older than 90 days, while new ones would be paid as they are," she explained.

Ms Epadile noted that bills which were classified as abnormal would be regularised and aligned with the average recorded in the past three months. Subsequently, she underscored the need for consumers to visit the WUC offices to get clarity and agree to payment plans suitable to their budgets.

On other issues, she said they would review the quantity of chlorine added to drinking water in Morwamosu to ensure that it was suitable for human consumption. She said even though the water needed chlorine as a disinfectant, keeping it in the right quantities would make it almost undetectable.

"I have noted your concerns about the chemical that we put in your water and we will have it checked because even though it has to be added to make water safe for drinking, you are not supposed to taste it," she said.

She noted that even though WUC was in the business of selling water, there were some exemptions since they acknowledge that water was an essential part of human life. She promised to make a follow-up on water shortage at Ikageng ward to determine if an intervention was needed to assist residents.

One of the residents, Mr Kebonamang Matsipane had requested that there should be a borehole at Ikageng ward to address water shortage in the area. "Water shortage is a concern at Ikageng ward and even our school going children do not have water to bath," he said. *BOPA*

Authorities urge government to act on Basarwa plight

LETLHAKENG - Local district authorities have urged government to act decisively on the plight of Basarwa communities.

The call for comprehensive solutions that respect the rights, culture, and dignity of the Basarwa came during a meeting convened by the inter-ministerial committee set up by President Advocate Duma Boko to look into the situation of Basarwa in Botswana to address long-standing and pressing issues they have.

Presenting number recommendations government action on Basarwa Letlhakeng issues. Council chairperson Gordon Mokgwathi proposed demarcating a portion of land in the Central Kalahari Game Reserve specifically for Basarwa well as drilling boreholes provide water access, and implementing a special dispensation for Basarwa students in education and government programmes.

Mokgwathi also highlighted the negative stereotypes and prejudices faced by Basarwa, stressing the need for government action to restore their dignity. "Basarwa have been unfairly labeled as lacking discipline and associated with vandalism. This negative image affects their educational performance and opportunities," Mokgwathi remarked, advocating for special consideration in government programmes to address long-standing disparities.

He praised the current administration for its human rights-based governance and emphasised the responsibility of all Batswana, including the government, to support Basarwa in achieving their full potential and dignity as fellow citizens.

Letlhakeng District
Commissioner Mr Ian Tema
highlighted the need for a more
consultative approach towards
Basarwa issues, emphasising that
past government decisions had
often been made without engaging
the Basarwa community.

"In the past, houses were built for the Basarwa without their input or consent, and when they were relocated from the game reserve, they were given cattle without access to boreholes for water," Tema stated.

He urged fellow government officials to listen to the Basarwa community before making decisions that impact their lives, saying, "We need to apply ourselves first and consult with the Basarwa people before taking action."

Village Development Committee (VDC) Secretary for Letlhakeng North Ms Kebafilwe Moselesele praised the government for consulting with communities living alongside Basarwa.

She said some communities who live alongside Basarwa learned to coexist harmoniously with them because they took time to understand their culture and identity.

She said it was important for all Batswana to embrace the Basarwa community and not discriminate against them. *BOPA*

Customers uptake of debt amnesty satisfactory

KANYE - Water Utilities Corporation (WUC) in Kanye has reported a positive reception of its debt amnesty programme, which is aimed at domestic customers.

This initiative is meant to aid WUC to recover about P30 million in outstanding dues from residential consumers.

In an interview with BOPA on Tuesday, WUC general manager Mr Monametsi Ramosu said the amnesty was intended to alleviate the burden of water bills arrears that had accumulated over time.

The amnesty allows customers to negotiate flexible repayment terms for their debts.

Mr Ramosu noted that many residents accrued debt during the early stages of COVID-19 pandemic when disconnections for non-payment were suspended.

The debt amnesty initiative covers all debts incurred prior to December 2024 and would be open for three consecutive months, from April to June 2025.

Mr Ramosu explained that under this programme customers were required to pay 50 percent of their outstanding dues within the three-month timeframe, while the government would cover the remaining balance.

Customers with bills incurred in 2025 will need to address

those outside the debt amnesty arrangement.

The corporation aims to significantly reduce the outstanding debt by the end of June 2025, while simultaneously helping customers to rectify their account statuses.

Early indications show a favourable uptake of the programme.

Mr Ramosu emphasised that WUC continued to promote the debt amnesty program through public announcements and was committed to addressing concerns from customers previously handed over to debt collectors.

He said these individuals would also have the opportunity to benefit from the programme, with WUC willing to withdraw their accounts from debt collectors and work with them directly.

He said while some may perceive the programme as a financial loss for the government, it was a necessary step to improve debt collection, citing that the WUC sees this amnesty as a means to recover funds that can support various government developmental initiatives.

Regarding businesses and government entities, Mr Ramosu said they would be obligated to settle their debts without special dispensations offered under the debt amnesty programme.

Wild Entrust wins Wilderness Impact Challenge

MAUN - Wild Entrust has been announced as the overall winner of the Wilderness Impact

Challenge 2025 and walked away with a monetary prize to the tune of P1.4 million.

The challenge is a conservation initiative by Wilderness

Trust focused on supporting transformative projects that improve human-wildlife coexistence and enhance wildlife security.

This year's challenge prioritised projects that address the challenges of humans living alongside wildlife, especially in areas where conflict and competition for resources exist. The challenge was open to individuals and organisations, which could come up with sounding proposals of resourceful solutions/projects aimed at advancing wildlife conservation in Africa.

Wild Entrust, through its project proposal, 'The Bioboundary', that aimed at developing new tools to reduce human-predator conflict by reducing predator attacks on livestock and the need for lethal control of predators, impressed the judges.

Speaking during a celebration to announce the winning project and honouring the people behind the idea on Tuesday, Wilderness Trust member, Mr Derek De La Harpe explained that the challenge was floated internationally in December and there were over 140 applications, which had to be reduced to a shortlist of 11. After further evaluation, the number was reduced to four entries.

"All were exciting and interesting projects that can address the urgent need for

creative solutions but the Bioboundary project outclassed other competitors to become the winner of the challenge and we look forward to working with them to expand the impact of the project on small scale farmers who rely on livestock," he added.

Mr De La Harpe highlighted that Wild Entrust presented an approach with the potential for lasting solution, noting that they expect the organisation to expand its research activities, especially on predators like lions in areas where Wilderness operates.

Senior researcher for Bio-Boundary Project, Dr Peter Apps, said the project has two main components, being the perimeter bio-boundary that deters predators from leaving protected areas by mimicking scent marks that demarcate home range and territories and bio-boundary repellents that use single components or simple mixtures of components of predator odours to keep carnivoures away from livestock.

The project operates in northern Botswana on the Hainaveld and Motopi ranches, a subsistence cattle post area west of Maun, and in the eastern half of Moremi Game Reserve and its neighbouring tourism concession areas. *BOPA*

Botswana hails AfDB for partnership

GABORONE - The African Development Bank (AfDB) has been hailed for not being just a financier, but a partner in the country's development journey.

The bank has in the past financed the construction of the Lobatse-Kanye Road in the 1970s, the Nata-Maun Road, Gaborone-Lobatse Water Supply and the Morupule B Power Plant.

Delivering a keynote address during the bank's 60th Anniversary Cocktail Dinner in Gaborone on Tuesday, the Vice President Ndaba Gaolathe, who is also the Minister of Finance, said AfDB was a fountain of innovation and foresight for the African continent's future, with its footprint woven into the story of Botswana's progress.

He said Botswana and the AfDB had walked together since 1972, from the days of concessional funding under the African Development Fund to the robust collaboration that the country enjoyed today, which exceeded more than P35. 8 billion (US\$2.6 billion) across 67 transformative projects.

"We have seen the bank not only as a builder of roads and dams, but also as a partner in thinking, reforming and re-imagining. through technical Whether in procurement reforms, lines of credit to our development institutions or policy advisory during our most difficult transitions. The bank has walked with us, quietly, consistently and

strategically," said Mr Gaolathe. For this reason, the Vice President said time had come for Botswana and the AfDB to deepen their collaboration further, urging the bank to establish a local presence in Botswana.

"We understand that physical infrastructure takes time however, having a representative can bring us closer more quickly. We are ready and we await your handshake," he said.

Mr Gaolathe said the bank's 60th anniversary celebration presented an opportunity for the African continent's renewed vision, expressing concern that the continent had long been misunderstood, because the world saw it only in statistics and not in its potential.

The AfDB, the Vice President said was a beacon of Africa's own dream, born of African minds, shaped by African hands and led by an unshakable commitment to the dignity, prosperity and empowerment of the African people.

Further, Mr Gaolathe commended the bank for leading conversations that challenged the world to rethink Africa, not as a continent of scarcity, but as the richest cradle of life on earth.

Africa, he said held over 30 per cent of the world's critical minerals, commending the AfDB's pioneering efforts to establish a unified African strategy for critical minerals and its proposal of a Critical Minerals-Backed African Currency.

the Earth has given us, rather than solely what markets dictate, we redefine the concept of wealth. Africans must be the custodians of their own resources, authors of their policies and the protectors of their future," said Mr Gaolathe.

AfDB deputy director general

for Southern Africa and country manager for Botswana, Ms Moono Mupotola said she embarked on her role, as the new country manager for Botswana, with profound respect for the country's vision and with a strong sense of responsibility to enhance the long standing collaboration and partnership.

"I eagerly anticipate working with all of you, to further the strategic priorities that will help Botswana with its ambition of becoming a high-income country.

Together we can deliver impactful results by ensuring that our collaboration continues to build tangible benefits to the people of Botswana and drive positive change that will propel Botswana and the continent towards new heights," she said.

The AfDB was established in in September 1964 to help drive development and economic growth across the African continent. From that vision, Ms Mupotola said the bank was born with a clear mission to reduce poverty and support sustainable progress on the continent.

"Since then, the AfDB has played a vital role in Africa's development story, it has grown, deepened partnerships and helped shape the continent's place in the global financial landscape," she

partnership with Botswana had come a long way, with the first loan extended to the country in November 1973, which supported the extension and modernisation of the telecommunication systems in the country.

"Another of our key projects has been the Pandamatenga Agriculture Infrastructure Development project, which supported increased production," she said, adding that Botswana and AfDB's relationship had been characterised by mutual respect and collaboration.


This time, the congregation is taking precautions, opting for 16 cars and a 16-seater combi instead of a bus.



It will take time for her to recover fully," said Ms Siako. The ZCC St Engenas Molepolole Branch is uncertain if there will be a memorial service for the deceased congregants during their pilgrimage, and await guidance from the church officials in Moria. A Fine Balance tackles complex issue

By Tshoganetso Mokowe

GABORONE - The struggle for coexistence between humans and wildlife in Botswana is a pressing issue that reflects broader global challenges.

AFineBalance, a documentary film directed by Robbie Kroger, explores complexities surrounding sustainable hunting and the ramifications for communities living alongside wildlife are examined.

film highlights The the precarious equilibrium these communities must maintain; balancing their survival against the needs of wildlife conservation.

Botswana, home approximately 130 000 elephants, grapples with the consequences human-wildlife conflict, particularly in areas like Sankoyo and Sepako and other communities in the periphery of wildlife parks.

The introduction of a hunting ban from 2014 to 2019 stripped locals of vital income linked to hunting quotas, which previously supported families and community development initiatives.

illuminates Kroger the paradoxes faced by those living near wildlife-rich areas, where the daily struggle for essentials like

water and pastures is hampered by the constant threat posed by elephants and other wild animals.

Kachelhoffer, Leon chairperson of Botswana Wildlife Producers Association, emphasises that hunting historically served as a buffer for the Okavango Delta ecosystem.

"Wildlife is our national heritage, and we have no intention of destroying it," he asserts.

Though ecotourism is suggested as an alternative solution to the conflict, many areas in Botswana, such as NG 13, an area in the Okavango Delta, remain under served and under developed for such ventures.

"It is crucial to develop strategies that enable rural communities to thrive, especially as poaching continues to be an issue," adds Kachelhoffer.

For villages like Mababe, hunting helps fund education and food security as it contributes to a trust the residents for development of the village, yet it is not without challenges.

Member of Parliament for Maun North and Leader of Opposition, Dumelang Saleshando notes that while Botswana may face criticism for its hunting policies, the reality is that responsible, communityinvolved hunting is essential for the region's sustainability.

He notes that international hunting lobby often portrays the situation in a negative light, overlooking the local perspectives.

"We need a fair, sustainable use of hunting; communities value wildlife, but the profit must also translate into real benefits for them," Saleshando argues.

Local voices emphasise the need for better resource allocation, so communities can benefit from hunting tourism rather than being left behind.

Trust Serumola, a local hunter, points that international hunters often receive premium treatment while locals struggle.

"We need tailored training programmes that prepare locals to engage at international standards," he explains.

As the documentary, A Fine Balance illustrates that challenges of human-wildlife conflict and hunting sustainably in Botswana is multidimensional, intertwining the economic survival conservation efforts.

The future of both wildlife and local communities hinges on developing sustainable practices that enable coexistence while ensuring that the benefits of wildlife resources reach those most affected.



GABORONE - Botswana tennis player, Seabo Saleshando has proceeded to the ITF World Tennis Tour Juniors J60 quarterfinals after beating Eric Sigauque of Mozambique 6-2, 6-2 at the National Tennis Centre in Gaborone yesterday.

Saleshando made his intentions of representing the country in the next round clear from the set go and dominated the second set, as his opponent was found wanting most of the time.

In a post match interview, Saleshando said despite being the only Motswana player to proceed to the quarterfinals, he would absorb all the pressure and play his normal game.

"But there were times that I played with a lot of nerves, and my intension is to correct that in my next match," he said.

Meanwhile, Botswana rising tennis player, Malak Macheng bowed out of the ITF World Tennis Tour Juniors J60 tournament after suffering a 6-1, 6-0 defeat from Allegra Van Der Walt of South Africa.

Despite losing, Malak will take solace in that making it to the second round and

earning her first ITF junior ranking points.

To qualify for the first round, Malak won against Zambia's Mukangwa Siame 6-4, 6-1 and went on to beat Tanaka Mhanga

In the first round match, she overcame Phuti Leshoele 6-0, 6-3 who tormented her in their previous clashes at CAT tournaments level.

However, her journey to proceed to the next round was stopped by experienced 17-yea-old, Van Der Walt's attacks.

Malak said in an interview that she was happy with her overall performance, adding that making to the second round of ITF was a bonus.

She said players from across the world came ready to compete, which exposed a lot of young players like her, to do better

Furthermore, she said the exposure also taught them new tactics, adding that the J60 tournament had given her a clear sign and prepared her for other future tournaments.
