# Ministry pledges to keep centre operational

**MAUN** - The Ministry of Child Welfare and Basic Education will look into issues that hinder the opening of the newly constructed Maun Centre for Children with Severe and Multiple Disabilities.

The Deputy Permanent Secretary in the ministry, Professor Agreement Jotia said during tour of the P183 million state-of-the art facility recently that it was meant to improve access to education for children with profound intellectual and multiple disabilities as part of government's commitment to educate all children regardless of their status.

However, the facility which was handed to the ministry last year, had not been enrolling learners as some vacancies had to be filled while the contractor was to also address teething problems as they arise.

The centre is expected to admit a total of 100 learners from across the country aged four to 18 years with severe motor disabilities and low levels of alertness of which 80 would be boarders while 20 would be day scholars.

Prof. Jotia promised that government would look into the challenges especially pertaining to vacancies to ensure the centre absorbed learners.

"Our priority is to appreciate facilities in our institutions so that we acknowledge the challenges and where possible try to bring some remedies," he added.

Prof. Jotia said the state of some facilities was pathetic, adding that some institutions had vacuum spaces that they called classrooms. He gave credit to teachers for demonstrating commitment despite the challenges they encountered.

Prof. Jotia also commended employees at the centre saying in the midst of the difficult circumstances, they still found hope to come to work and be able to render their services so that the wheels of the government could move and the services reached the masses.

He also acknowledged that government was considering the pillar of inclusive education for all. The facility, he said, stood as an example of inclusive education.

Prof. Jotia promised that the ministry would do all it could to get the facility running.

He said the facility had to open doors to children, indicating that there were a lot of cases from parents about issues of marginalisation of their children with disabilities.


Earlier on, the centre coordinator who is also head of the Diagnostic and Rehabilitation unit, Ms Duduetsang Moroka, described the centre as one of its kind in the country, which would provide a holistic quality education and rehabilitation to children.

The centre, she said would ensure that no child was left behind in education.

She said currently the centre had employed 30 permanent and pensionable employees and eight temporary staff, stating that they still had vacancies for particular officers like rehabilitation personnel.

She said they could not run at full capacity until such vacancies were filled because the rehabilitation personnel, which comprised of diverse professional, worked collaboratively to support children with disabilities. The intention, she said, was to have a phased approach to admit learners once the centre was fully operational.

Ms Moroka also noted that the centre had a guest house and hostels but there was no basic furniture procured. The guest house would accommodate parents during their visit to check on their children. She also highlighted that some buildings could not be occupied because of electricity issues but appreciated that they had shared a list with the contractor to attend to. *BOPA* 



# NATIONAL GENDER COMMISSION RESPONSE TO CYBER BULLYING

The National Gender Commission is alarmed by the pervasiveness of sexist cyber bullying on social media.

Young women and girls, as well as vulnerable and marginalised groups, and marginalised genders; face constant harassment and discrimination online. Women and young girls are being subjected to derogatory comments, threats, insults, harassment, unsolicited sexting (sending sexually explicit mobile messages and images), derogatory morphing (using digital tools to alter images), virtual rape (non-consensual sexual violence online), revenge porn, flaming (sending angry and or insulting messages online), public shaming and objectification simply for being normal.

This outrageous reinforcement of harmful stereotypes and discriminatory societal norms is a form of gender-based violence that must be addressed urgently.

The cyber bullies derive perverse pleasure from the impact of this appalling psychological violence which they perpetrate with relentless impunity to trigger isolation, continuous scrutiny, and negative judgement. Women and young girls in Botswana have suffered relentless degrading exposure, which undermines their self esteem and sense of safety.

This diabolical trend unashamedly rides on the misguided coattails of misogyny and systemic discrimination born of our unfortunate traditional culture, where women's voices are marginalised; and 'modern' trends where women's bodies are objectified.

By targeting women and girls and undermining their self esteem, and sense of safety; cyber bullying is perpetuating a cycle of oppression that is deterring women from participating in the public discourse, professional spaces and online communities.

The chilling effect is that of silencing the voices of women politically, socially, economically and spiritually.

- These criminal cyber bullies engage in body shaming of girls' bodies, so that they end up not going to school and failing.
- They denigrate women for what they wear like they did when Hon Lesego Chombo wore gym tights for a GBV awareness walk.
- They insult and question women's intelligence; by suggesting that they can't lead and should stay at home

#### The National Gender commission calls for:

- 1. A more comprehensive enforcement of the laws addressing cyber bullying; with the application of appropriate penalties to offenders.
- 2. Urgent public and school educational programmes as well as teacher training on GBV including cyber bullying.
- 3. All social media platforms to prioritise safer environments, with moderation policies, dismantling toxic behaviours, introducing more robust reporting systems.
- 4. The long overdue GBV law must address more extensively, this abhorrent sexist cyber bullying.

Most of all we call for responsible behaviour online and a safe environment for women and girls. It is their constitutional, and human right.

# Boko kick-starts Kgale View housing project

GABORONE - The ground breaking ceremony of the Bonno Target 3 000 Housing Development project is the commencement of government's journey towards the delivery of 100 000 housing units to President Batswana, says Advocate Duma Boko.

Speaking during the event in Kgale View yesterday, he said it was with a deep sense of pride to launch the project, which was a segment of a large and unfolding narrative of the 100 000 units promised.

"Botswana is going to look spectacularly different within the next three years. I have a team of people I work with and we dare not fail. We should have a culture of selflessness, humility and appreciating that the people expect us to give our all for them," he said.

President Boko said a low wage economy in the past did not attract acceptable foreign direct investment (FDI) and that left many citizens impoverished including those with formal employment.

He said government had made an indication of the construction of 100 000 housing units by comprehensive developing schemes for affordable housing.

"The workers are complaining, there is generalised discontent about these past systematic injustices and we need to wrestle with this on the trot. We are as government charged with the responsibility of resolving these injustices and we are going to do that in the shortest possible time," he said.

President Boko government was not only offering Batswana shelter, but opportunity to own real property in terms of housing units.

"We begin with this 3 000, it is the beginning of an ambitious project of wealth transfer and at the end of this, 100 000 shall have titles to real property, a house which is vital in life, democratisation of wealth because we want people to have decent livelihood," added President Boko.

He said government had set an ambitious target of delivering the project within two years and called on all stakeholders to come on board and realise this vision.

He said the indirect jobs to be created by the project must at least reward labour at the lowest P4 000.

"There is no legislation compelling this, but moral and economic argument does compel us to do so. Confidence and renewed faith must be given to our people," said President Boko.

Giving an overview of the project, Minister of Water and

Human Settlement, Mr Onneetse Ramogapi said Bonno Target 3 000 was the first step towards delivering the promised 100 000 housing units.

He made an assurance that all people working on the project would be given the envisaged minimum wage of P4 000.

The minister said the project would be unfolded in two phases,

which would turn out to be a marathon race expected to be delivered within 24 months.

He said government resolved to use direct appointment for the project as the tender process was lengthy.

Mr Ramogapi appealed to all Batswana to show interest and be part of the journey.



# Shortage of on-call doctors strain hospitals

**GABORONE** - Despite the ongoing emergency call crisis, most hospitals across the country continue to function, with the exception of Palapye and Kasane where a shortage of doctors responding to emergency duties has caused concern.

Addressing a press briefing yesterday, Minister of Health, Dr Stephen Modise said government remained committed to ensuring every Motswana received quality healthcare, regardless of

While many doctors have continued performing duties as rostered, he said a number have opted out of extra emergency calls, particularly in key referral hospitals and a few

districts.

"In Palapye, five medical officers have informed the Chief Medical Officer that they will not be doing extra calls. In Kasane, six out of nine had taken the same stance. This has placed strain on the remaining few," Dr Modise said.

He said the matter emerged from a long-standing dispute between government and the Botswana Doctors Union over emergency call conditions and allowances.

While doctors insisted they were not on strike, some were limiting their emergency calls to once a month, a decision the minister described as harmful to patients and contrary to their conditions of service and a court

Minister Modise assured the public that contingency plans were in place, with hospital teams being reshuffled to cover critical services.

He thanked the majority of doctors who have continued to respond to emergency duties and acknowledged private sector doctors who have volunteered their services.

"We will engage doctors through the proper platforms and work towards resolving this impasse," the minister said.

deputy The ministry's manager employee relations, Mr Thapelo Koketso added further clarity, noting that although an agreement was reached in April 2023 to pay emergency call allowances effective from 2022, the full implementation was

scheduled for May 2024.

Also, he this implementation hinged the submission of finalised emergency call policies, contracts and schedules expected by July 2023.

However, he said delays and disagreements over the adequacy of a proposed 15 per cent allowance led to a stalemate.

"The government's position has always been to take this matter to the negotiating table," he said, adding that negotiations on allowances were held again in December 2024 and March-April 2025.

He emphasised negotiations were formally held only once per year, which limited the pace of resolution on salary-related issues. BOPA

# Dr Seleke soars to new heights

**GABORONE** - Dr Thabo Seleke's journey from the dusty streets of Mochudi to the halls of global health policy is one marked by perseverance, academic brilliance and an unrelenting desire to make a difference.

Born in Mochudi, his early schooling took him to Selebi-Phikwe where he laid the foundation for a career in the public service.

Driven by a curiosity for how systems work and how they can better serve people, he later enrolled at the University of Botswana to study Public Administration.

Upon graduating, he was honoured with the prestigious Roderick Ross Award, bestowed upon the most outstanding student in the Department of Political and Administrative Studies in the Faculty of Social Sciences.

That early recognition marked the beginning of a career defined by purpose. In 2001, he joined the Ministry of Health where he served diligently for two years before transitioning to the Botswana Telecommunications Corporation.

Organised by the Tsabong District Council (TSDC) under the theme, 'Taking services closer to people', the Boravast community outreach promises to be a comprehensive initiative bringing together various essential services.

According to TSDC Secretary, Mr Mosimanegape Mogorosi, the event was set to take place at the Bokspits community hall starting at 9am and would feature representatives from council departments, central government departments, and parastatals.

He said this collaborative effort aimed to streamline access to crucial services for the local population.

He further explained that the attendees could anticipate engaging with different departments and organisations, potentially gaining valuable information and assistance on a range of issues. This initiative underscores a commitment to bringing the necessary resources directly to the community, fostering greater accessibility and convenience for residents, said Mr Mogorosi. *BOPA* 

Despite a thriving professional path, Dr Seleke never lost sight of his academic ambitions.

A scholarship opportunity from Belgium, reserved for SADC scholars, allowed him to pursue a Master's Degree in Public Administration.

That pursuit would eventually catapult him onto the global stage.

Fast forward to June 2024, Dr Seleke successfully completed his PhD in Health Policy and Systems Research at the London School of Hygiene and Tropical Medicine within the Faculty of Public Health and Policy.

By October, he had defended his thesis and in February 2025, he walked across the graduation stage in celebration of a significant academic milestone.

A month later, the university formally endorsed his thesis following rigorous peer review.

In an interview with *BOPA*, Dr Seleke describes his study as ground breaking.

While many studies on Non-Communicable Diseases (NCDs) have been conducted in Africa, his is the first to employ qualitative research methods to examine the subject.

His findings offer critical insights into Botswana's national response to NCDs, which by 2021 accounted for 38 per cent of local mortality.

He notes that South Africa's rate is even higher at 58 per cent while the global average stands at 34 per cent.

"To date, there are gaps in scholarly work and understanding regarding NCDs responses in Africa," he observes.

He stresses the urgent need for Botswana to adopt a multisectoral approach to preventing and controlling NCDs, one that mirrors the country's coordinated response to HIV/AIDS. Dr Seleke

now plans to engage policymakers and stakeholders and will soon host a public lecture to share his findings more widely.

His passion for health policy and systems reform is further evident in his academic pursuits.

He is a Fulbright Scholar, having earned an MSc in International Health Policy and Management from Brandeis University in Boston, Massachusetts.

He also completed a fellowship at the Duke University's Sanford School of Global Health and has worked with the World Health Organisation in Geneva on pandemic and epidemic policy.

Further training at the Harvard T.H. Chan School of Public Health and Boston University School of Medicine where he studied ethical issues in international health research as well as advanced qualitative research

at King's College London, have fortified his credentials.

His participation in the Global Leadership Training Programme for Sustainable Development in Africa and epidemiology training in The Gambia round up his formidable academic resume.

Dr Seleke also holds a Postgraduate Diploma in Strategic Management from the University of Derby in the UK.

Beyond academia, Dr Seleke has made practical contributions to health policy and systems across the continent.

His consultancy work has included projects for the World Bank in Lesotho (IKAP study) and the European Commission's initiative on strengthening community health systems for HIV treatment and care.

He has collaborated with universities across Europe

including in France and Finland and has been involved in regional studies in countries such as Zimbabwe, Malawi, Mozambique, Namibia and Tanzania.

Currently, Dr Seleke serves as co-investigator on a research project focused on cervical cancer, continuing his unwavering commitment to addressing the most pressing health challenges facing Botswana and the region. **BOPA**

# Thieves rob Taj Boutique clothing worth P87 000

**MOLEPOLOLE** - Police have launched an investigation after the Taj Boutique in Molepolole was broken into, and thieves made off with an estimated P87, 000 worth of clothing.

Molepolole Station Commander, Superintendent Jacob Molapong, told BOPA that the robbery occurred during the holiday weekend.

He said it is suspected that the suspects entered the store through the roof and they managed to escape with the stolen merchandise undetected. "We are still actively looking for the individuals responsible for this crime," Mr Molapong stated.

"We encourage anyone with information about the incident or the whereabouts of the stolen merchandise to contact the police immediately."

In addition to the Taj Boutique robbery, Mr Molapong said Molepolole police have registered two fatal accidents that occurred over the long weekend.

He said on Friday around 1am, a Toyota Runx hit a parked truck after the driver lost control.

Both the driver and a female passenger lost their lives on impact.

He said the second accident occurred on Saturday around 1am when a 27-year-old man lost control of his Toyota Corolla crashing into a tree.

Mr Molapong explained that there were five passengers in the Corolla, two men and three women, who were allegedly returning from a night club at the time of the crash.

female passengers sustained minor injuries and were treated and discharged from the Scottish Livingston Hospital," he said.

remaining The three passengers, two men and one woman, suffered serious injuries and have been admitted at the Scottish Livingston Hospital.

The police have not ruled out the possibility that alcohol was a factor in the accidents. BOPA

# Court arraigns two for separate murder charges

**MOLEPOLOLE** Molepolole Magistrate Court today Tuesday arraigned two men on separate murder charges that occurred over the Easter holiday weekend.

Appearing before Molepolole Magistrate, Mr Johnny Baakile, the accused, a 62-year-old Modise Gasentsima and a 29-year-old Mr Kelebogile Dinake, were formally read their charge sheets and the particulars of the offences.

Mr Gasentsima was accused of murdering Mr Ofentse Tshepo Diphakedi on April 19 at Borakalalo ward in Molepolole while Mr Dinake was also

arraigned for the murder of Mr Thinkwell Mnkandala at Dikgonnye lands on April 17.

Magistrate Baakile heeded the requests of the state prosecutors, Sergeant Thatayaone Marope and Sergeant Pako Kgosimolao, and remanded both accused person in custody at Molepolole Prison until May 12th.

The prosecution had argued that, given the nature of the crimes and the ongoing investigations, custodial remand was necessary for both men.

While the holidays were largely peaceful in Lekgwapheng, apart from the two murder incidents, the police noted an increase in house break-ins. BOPA

# Soldier lands in trouble over threat to kill

**MOLEPOLOLE** - Molepolole Magistrates' Court on Tuesday arraigned a 30-year-old soldier Barracks (SSKB) for three offences including a threat to kill.

The accused, Chiyapo Mwanza from Mathangwane, is charged with three counts which were formally read to him in Court.

The first count, that relates to an alleged threat to kill, states that on or about April 20, at or near Legonono ward in Molepolole, Mwanza allegedly caused Ms Onkarabile Moadi to receive a threat, uttering the words, "Wa lebala gore ne ke berekela ko ditlhobolong ke tlaa go hula be ke iphula kana ke go bolaya," roughly translated as "You forgot that I work with guns; I will kill you and kill myself."

On second count, he is charged with common assault, as he

allegedly hit Ms Moadi with a Corona bottle on the nose, causing her minor injuries.

The third count alleges that the accused damaged a Samsung stationed at Sir Seretse Khama A23 cell phone, valued at P1 500, owned by Ms Moadi, an offence of malicious damage to property.

Pleading his innocence, the accused requested bail from Magistrate Baakile, stating that he had reconciled with the complainant, who reportedly told him that she filed the charges because she was hurt.

However, State Prosecutor Sergeant Thatayaone Marope countered the accused's assertions, citing incomplete investigations and the fact that the complainant was still pursuing the matter. The court ruled in favour of the prosecution's request and remanded Mr Mwanza in custody until May 6 when a formal hearing of the matter will commence. BOPA

Oageng called capacitation of teachers saying when they invite experts, they wanted to be sponsored. Despite the challenges, he acknowledged stakeholder involvement citing that they worked closely with tourism companies, such as African Bush Camp which operates camps in the Okavango Delta saying it empowers learners to get exposure in the wilderness.

Other organisations worked in collaboration with the school, include Botho University, Women in Tourism Botswana and Botswana Chefs Association.

Prof. Jotia appreciated the challenges and gave credit to teachers for educating learners with the little resources they had.

He informed school management that efforts were ongoing to engage with Botswana Examination Council to address the issue of payment of teachers.

In terms of schools' performance in the North West and Okavango regions, he said there was a serious problem that needed to be addressed, saying it was disturbing to learn that pupils excel at primary but fail at junior and secondary schools.

"I have been informed that pupils at Gunutsoga Primary School scored 73 per cent overall pass rate and when they reached Ngambao Junior School, their performance dropped to ten percent.

"This is disturbing and we need to come back to the region and get to the bottom of the problem," he said. BOPA

# Africa shifts to new economic paradigm

**YAOUNDE/BEIJING** - US

President Donald Trump recently announced sweeping tariffs on numerous countries, including many in Africa, disrupting the international trade order.

While Washington has since granted a 90-day reprieve for most of the affected countries, analysts believe the pause is likely temporary rather than a full reversal.

In this context, the African Growth and Opportunity Act (AGOA) -- a trade pact launched in 2000 and set to expire in September -- faces a bleak renewal

Economists and policy experts argue that Global South countries must bolster self-reliance and enhance South-South cooperation to counter rising US protectionism and unilateralism.

In early April, the US government announced a new wave of tariffs targeting a wide array of countries, with several African economies among the hardest hit.

The measures include duties of up to 50 percent on goods from Lesotho, 47 per cent from Madagascar, 40 per cent from Mauritius, and 37 per cent from Botswana.

Robert Kahn, managing director for global macro at political risk consultancy Eurasia Group, acknowledged that the policy has led to "a large number of absurd figures that are meaningless."

Lesotho, a small mountainous country of about two million people, has reportedly imposed reciprocal tariffs of 99 per cent on US products, according to the Trump administration.

Consultancy Oxford Economics noted that Lesotho's textile sector, which employs approximately 40 000 people, is especially

vulnerable.

"The 50 per cent reciprocal tariff introduced by the US government is going to kill the textile and apparel sector in Lesotho," said Thabo Qhesi, an independent analyst based in Maseru, Lesotho's capital.

"Then you are having retailers who are selling food. And then you have residential property owners who are renting houses for the workers.

So this means if the closure of factories were to happen, the industry is going to die and there will be multiplier effects."

In the long run, the indirect effects of trade disruptions, global trade wars, and the closure of Western markets could pose significant challenges for African economies, which depend heavily on exports as a primary source of income and foreign exchange, said Celestin Monga, a Cameroonian economist and former vice president of the African Development Bank.

"A global economic slowdown means reduced demand for oil and other raw materials, which in turn causes a drop in the prices of crude oil and other unprocessed African products," Monga emphasised.

AGOA, provides which preferential duty-free access to the US market for over 30 African countries, has played a key role in supporting export-led growth across the continent.

However, with the imposition of high US tariffs, analysts warn that the renewal of AGOA appears increasingly uncertain, and it may not survive to its 25th anniversary.

Cameroonian economist Michelle Josee Ekila noted that uncertainty surrounding AGOA's future could significantly constrain trade and drive up costs for African exporters.

While African countries are pushing for a 10-year extension, many economists doubt whether the current US administration is committed to continued cooperation.

"The US tariffs effectively nullify AGOA," said Daniel Silke, director of South Africa's Political Futures Consultancy.

The director even warned that the programme could be terminated before its scheduled expiry unless African countries demonstrate strong strategic value to justify its continuation.

In response to these mounting challenges, African leaders and economists were calling for a shift in strategy.

Monga suggested countries African national development banks and mobilise both public, private and institutional financing to develop industrial parks centered on local production and processing.

These would serve emerging markets eager for "Made in Africa" goods that meet international standards.

Ekila emphasised the need to diversify export markets. "Exploring trade agreements with other regions, such as the European Union or Asia, could offset losses from the new tariffs." Nkolo Foe, a former professor at the University of Yaounde I, echoed the urgency for South-South cooperation. "The measures taken by Donald Trump directly impact the Global South and are destabilising the international order and peaceful coexistence.

The countries of the Global South, and particularly Africa, are waking up."

Humphrey Moshi, director of the Center for Chinese Studies at the University of Dar es Salaam in

# 'Trade policies pose economic uncertainty'

**CAIRO** - The unilateral protectionist policies adopted by the United States, particularly those related to tariffs, are harming the global economy, impacting international supply chains and unsettling financial markets, Egypt economist has said.

The tariffs imposed by Donald Trump's administration whether on its allies or so-called adversaries are likely to drive up operating and production costs for businesses worldwide, as well as disrupt the established global supply chains, Karim Adel, head of the Cairo-based Al Adl Center for Economic and Strategic Studies, told *Xinhua* in a recent interview.

Egypt, economy relies on industries that required the import of raw, semi-finished, or manufactured materials, ass such it was likely to be affected due to rising costs, he said.

However, he pointed out that Egypt still had the opportunity to mitigate the severity of the US measures by strengthening partnerships with countries like China.

He noted that Egypt and China had strong and fruitful bilateral ties and enjoyed a positive momentum of cooperation across numerous sectors, adding that the current global economic situation could be an opportunity to boost bilateral cooperation even further.

His expectation was for China to be seeking such enhanced cooperation in the coming period, considering its significant investments and business operations within the Suez Canal Economic Zone and various other Egyptian cities.

"Through frameworks like the Belt and Road Initiative and BRICS, China's substantial economic capabilities can help bolster the resilience of numerous other countries in defusing trade and financial crises stemming from the unilateral

measures of the United States," Adel said. He suggested that economies around the world, particularly those in the Global South, proactively strengthened their

cooperation efforts to mitigate the potential

# China adds 29 new majors to higher education catalogue

**BEIJING** - China's Ministry of Education has introduced 29 new majors to advanced education institutions in response to the evolving needs of national strategies and the pursuit of high-quality development.

The ministry yesterday announced updates to the catalogue of undergraduate majors in general colleges and universities, adding majors such as carbon neutrality science and engineering and international cruise management. Among the new additions serving strategic areas of national interest are majors such as marine science and technology and health and medical security.

In recognition of technological trends, majors including smart molecular engineering, medical device and equipment engineering, and spatiotemporal information engineering have been included. To cater to emerging market trends, the catalogue now includes majors such as international cruise management and aviation sports.

Reflecting the growing role of artificial intelligence (AI) in modern society, the ministry has introduced majors such as AI education, smart audio-visual engineering, and digital drama.

To facilitate a more agile response to national strategies, the ministry has implemented a new mechanism allowing swift adjustments to the curriculum in response to newly prioritised strategic areas.

Addressing the rapid development needs of the low-altitude economy, six universities, including Beihang University, have been guided to add a major in low-altitude technology and engineering. *Xinhua* 

# Abandoned mines turn to ecological oases

**TAIYUAN** - From jagged craters to golden wheat fields, China's scarred mining landscapes are undergoing an ecological revolution.

In Xinanyu Village, north China's Shanxi Province, a once-barren refractory clay quarry is now fertile farmland a testament to the nation's multipronged strategy to heal nearly 300 000 hectares of abandoned mines since 2016.

"Five years ago, this site resembled a bombed battlefield, bedrock exposed, soil erosion rampant," recalled Ma Baosheng from Yangquan City's natural resources bureau, standing amid restored cropland.

His city, part of Shanxi's coal belt, has transformed multiple derelict mines through targeted engineering and ecological zoning.

Shanxi has invested a total of about US\$288 million to rehabilitate 2 400 sites totaling 6 900 hectares, stabilising slopes, rebuilding topsoil, and curbing geological hazards on those lands.

The rehabilitation process exemplifies China's science-driven restoration model. Tailored approaches such as engineering interventions for severe degradation zones and nature-based recovery for less damaged areas were adopted. China's ecological overhaul extends beyond physical restoration.

A policy revolution began in 2019 when the Ministry of Natural Resources introduced mechanisms to explore market-based approaches to promote mine ecological restoration, which was amplified by 2021's private capital incentives by the State Council.

A total of 49 pilot projects under this model now demonstrate how former environmental liabilities could become carbon sinks or solar farms.

Geological engineer Hu Haifeng from Taiyuan University of Technology explained the technical nuances said, "For high-risk sites, we deploy slope terracing and vegetative reinforcement. In areas like some abandoned mines, adaptive reuse such as agritourism hubs can generate new economic value.

These sites were ecological debts," said Ma, gesturing towards newly planted saplings. "Now they are appreciating assets, feeding communities and sequestering carbon." *Xinhua*

## UN agency opens migration response centre

**MOGADISHU** - The International Organisation for Migration (IOM), the UN migration agency, has officially inaugurated the Migration Response Center (MRC) in Burao, Somaliland, a self-declared region of Somalia.

The IOM said the inauguration marked a significant milestone in expanding the provision of essential protection services and support to migrants on the move in the region.

Prestage Murima, IOM Somalia deputy chief of mission, said the establishment of the Burao MRC was a testament to the ongoing commitment of the IOM and its partners to addressing the needs of vulnerable migrants.

"By strengthening protection mechanisms and providing lifesaving services, we aim to ensure that no migrant is left behind," Murima said in a statement issued in Burao.

The newly established MRC, which joins a growing network of centres in strategic migration corridors, will serve as a critical hub for protection services and voluntary return support for migrants in transit, as well as those stranded along migration routes.

IOM said the centre will provide emergency shelter, medical assistance to vulnerable migrants, assisted voluntary return, mental health and psychosocial support, awareness raising, information sharing and distribution of non-food items.

IOM Somalia's Migrant Protection and Assistance Program, oversees the MRC network across Somaliland and the broader region, continues to work with government partners and donors to expand access to protection and assistance services for migrants. Xinhua

# **Exhibition** highlights US-China bond

#### **FRANCISCO** SAN

Descendants of the Flying Tigers, along with US and Chinese officials and World War II history activists, gathered in San Francisco on Monday to open a new photo exhibition that honours the historic bond between the American and Chinese people during their joint fight against fascism in World War II (WWII).

The exhibition, titled: Sino-American Friendship - Flying Tigers in Guangxi, is organised by the Department of Culture and Tourism of the Guangxi Zhuang Autonomous Region.

It runs through May 4 at the WWII Pacific War Memorial Hall in San Francisco Chinatown.

Featuring 29 panels of historical photographs, the exhibition highlights the heroic contributions of the Flying Tigers an American volunteer group that aided China during its War of Resistance Against Japanese Aggression.

The images also reflect the deep friendship forged between the two nations as they stood shoulder to shoulder during one of the most turbulent periods in modern history.

Guangxi was a key strategic location for the Flying Tigers, who operated from bases in cities like Guilin and Liuzhou. From there, they launched daring bombing raids on Japanese targets in Guangzhou, Wuhan, Hainan, and beyond crippling supply lines and bolstering China's resistance efforts while contributing to the global fight against fascism.

Charlene Fontaine, descendant of a Flying Tigers veteran, shared personal stories passed down from her father.

She emphasised the oftenoverlooked bravery of the Chinese people.

"When we said how much our dads did to help save China, my father always said it was the courage and resilience of the Chinese people that saved them," she recalled.

Wei Jiang, deputy director of Guangxi's Department of Culture and Tourism, highlighted stories of American pilots rescued by Chinese villagers who risked their lives to shelter them from enemy forces.

Wei announced that a larger more comprehensive exhibition on the Flying Tigers will open this September in Liuzhou City, and he invited Flying Tigers descendants in the United States to contribute historical materials and visit the upcoming event.

Local elected officials also attended Monday's opening ceremony.

"We are here to honour the men, the women, and the history of an incredible event," said Danville Vice Mayor Newell

"History is something that we need to learn from and it guides us to our future." San Francisco Supervisor Chyanne Chen praised the exhibit as "a valuable live classroom."

She said the US-China relationship was important, and remembering the sacrifices of those who fought for peace was something that should continue to be honoured. *Xinhua*

However, nearly Rwandans can now speak Chinese after years of sustained efforts.

He noted that Chinese language skills have opened doors for At present, more than 190 Rwandan learners, enabling them added. Xinhua

to secure jobs, win scholarships, study in China, and even start businesses.

"I have seen Chinese learners achieve their dreams through the language, by creating enterprises or finding good jobs. They are truly changing their lives through learning Chinese.

English is used worldwide, but Chinese is a rising language in East Africa and across the globe. It represents the future," Zeng

### Heritage survey highlights modern-era sites, architecture

**BEIJING** - China's ongoing fourth national cultural heritage survey will prioritise the identification of historic sites and architectural works from the modern era, according to a directive that the National Cultural Heritage Administration made public on Monday.

The circular urges local authorities to step up their investigations modernera buildings with regional features, distinctive styles, special functions, or historic value especially those tied to local industrial or community development, or designed by prominent architects.

It stipulates that qualifying sites should be documented and added to the national heritage protection system, regardless of previous designation status.

It also calls for strengthened efforts to identify cultural relics linked to major phases of contemporary Chinese history, including the legacy of the Communist Party of China, the founding of the People's Republic of China, the country's reform and opening-up period, and the

evolution of socialism.

A separate circular from the survey's leading group office issued on the same day emphasises intensified discovery work in historically significant areas such as old city centres, famous towns and villages, heritage districts, and traditional rural settlements.

All structurally intact buildings

built before 1911 should be surveyed and protected if they meet relevant criteria.

Launched in 2023 and running through 2026, the ongoing survey is China's first national cultural heritage survey in over a decade, marking a major nationwide effort to reassess and expand the country's cultural relics inventory. Xinhua

has a rightful place in it. Kesitilwe highlighted that racing directly contributed billions to economies and created thousands of jobs globally.

He cited that in the South Africa, neighbouring expenses of organising a horse race could go over P2 million, supporting over 60 000 jobs for jockeys, veterinarians and betting and gaming operators like Sunbet and many more.

"These direct economic activities also prompt additional economic activity outside the horse industry and this is an indication that the industry is vibrant and alive," he added.

He appreciated sponsors of the Masa Horse Race, Sunbet Botswana and Mascom for their valued support and their services, citing Sunbet with betting goods onsite, which he said was a sign of growing confidence in the industry.

Kesitilwe said horse racing betting should be entertaining, but at the same time should be done responsibly, adding that was why the authority continued to promote safe and sustainable gambling practices.

Member of Parliament for Maun East, Goretetse Kekgonegile concurred that horse racing had the potential to diversify and contribute significantly to the economy and create employment opportunities.

Traditionally, agriculture including horse racing, he said, was a source of income for the rural community in the North West region.

"Horse racing is part of our tradition. It brings us immense joy to contribute to a platform that drives social economic impact and our office has the intention to engage with Masa Horse Race organiser to see if we can enter into a joint venture through Community Constituency Programme (CCP) because our aim is to see the race being one of the country's top race," he added

Kekgonegile said through a partnership, they could consider putting developments at the horse racing farm to match the international standard.

The event manager, Otukile appreciated that the event was successful as it had attracted a huge crowd of horse racing enthusiasts from all corners of the country. He also thanked the sponsors and all who contributed to the success of the event, saying the activity did not only bring fun but it also promoted sport tourism in the region.

# Bakwadi to clean up house

**GABORONE** - Belligerent members of Botswana Karate Association (BOKA) who undermine the authority of the Karate governing body and violate the constitution and code of conduct will face the music.

In an exclusive interview with *BOPA* following the expulsion of two members of BOKA, Shukokai Shito-Ryu and Kofukan Federation of Botswana, the association's president Shihan Mpho Bakwadi admitted that karate had been rocked by squabbles due to dissident elements within their structures

The association has been experiencing a turbulent period with bitter internal strives seen as being the centre of the rot. Factional divisions, leadership squabbles and embezzlement of funds were fingered as some of the challenges that bedevilled the sport.

"Going forward those who compromise the integrity of karate, those who bring it into disrepute will be dealt with. We have to bring karate back to its roots. We are in that drive to apologise to the public about this rot, make our stakeholders comfortable and make an assurance that karate is back and in good hands," said Bakwadi.

Bakwadi said the decision to expel the two members was taken after a majority vote of a special general meeting convened last weekend in Gaborone.

The two expelled members had voted out the Bakwadi led committee through a motion of no confidence passed by Botswana Kofukan and seconded by Shukokai.

BOKA had earlier warned that those who would attend any unauthorised meeting would face suspension or even expulsion.

Nonetheless a special meeting was convened attended by five federations namely Kofukan, Goju-Kai, Karate Nomichi, Shukokai and Ryushin-Kan.

The five members had, in January submitted a petition to BOKA raising a number of alleged anomalies at the association among them violation of the constitution, lack of financial transparency and unlawful appointment and noncompliance with constitutional procedure.

High Court ruled that the meeting was illegal and any decision taken there was not recognised. Bakwadi explained that amongst

other serious breaches the two members collaborated with individuals and organisations outside BOKA to unlawfully overthrow the legitimate executive of BOKA.

He said the expelled members approached the registrar of societies under false pretences claiming to be the legitimate executive of BOKA and also convened and attended unauthorized and unlawful meetings.

Bakwadi said these actions were seen as constituting gross misconduct and undermining authority hence the expulsion was finalised and binding.

He said in 2023 his committee was voted into office after serving on an interim basis for some time replacing the Sensei Tshepo Bathai led committee which was ousted by a motion of no confidence.

Bakwadi said following the leadership coups that had become a common feature at BOKA his first assignment was to clean up the mess and deal with the debt which was in excess of Plmillion.

"We spent the whole of 2023 clearing debt through our subvention funding because we owed hotels and travel agencies amongst others. But after that we were able to take part in regional and continental championships such as zone VI in Zimbabwe where we did well. We took part in Africa Games in Accra and our ladies' kata team qualified for the world championships in Pamplona," he added.

BOKA was then embroiled in court

battles as the Bathai-led committee comprising of Bathai as president, Sam Dire as Vice president administration, Karabo Samuel (secretary general) and David Hubona (VP technical) took BOKA to court contesting their ousting from the karate office. They later withdrew the case. Kofukan and Shukokai joined forces with the concerned group some expelled from BOKA and the High Court dismissed the case.

High Court ruled that the sensei Koorapetse Mogopodi led interim committee was unlawful and illegal.

BOKA then

convened a meeting to expel the two on grounds of collaborating with members outside BOKA.

"We made it clear that you can't remove a constitutionally elected executive illegally. We are known for being an ancient discipline with integrity. We have engaged Botswana National Sport Commission, Botswana National Olympic Committee and the ministry of sport and we are now part of the Africa Union Sport Council Region 5," he said.

Bakwadi reiterated that restoring the dignity of BOKA was top of his agenda and pledged working extensively with relevant stakeholders to further advance development of karate.

He applauded BOKA's partners for all their efforts in bringing sanity to its leadership and said it was a privilege to work with willing partners for the growth of the sport.

Bakwadi who is now the current president of the karate association was recently appointed as the second vice president of the Commonwealth Karate Africa Association (CKAF) a position he said would allow him a chance to set ambition goals to elevate the local sport to greater and new heights.

The CKAF appointment mandates Bakwadi to coordinate activities of the association in the Southern African region, support the association's president in furthering the sport's development.

He expressed immense gratitude to the appointment and said global partners were acknowledging his good leadership qualities.

Bakwadi took over Bathai and were expected to ensure full participation of affiliates following the mess that destabilized the association over the years.

He brings with him a full set of an executive committee charged with ensuring that he passes the litmus test. Bakwadi is assertive that ertenal peace would soon prevail despite the dark veil that befell the sport over the past decade.

Bathai who was initially removed from office in 2014 through another motion of no confidence returned to the karate top seat in 2017 after taking over from prominent

sport administrator sensei David

Sensei Mathe was in office for a two-year term and survived a motion of no confidence. He withdrew from the race for presidency in 2017 when Bathai took over.

Sensei Abel Mbaakanyi became president of BOKA from its infancy until

from its infancy until Sensei Jeff Tembo, considered the longest serving BOKA president took over succeeding Mbaakanyi. Ookeditse Malesu, Gift Nkwe and Million Masumbika also took up office as BOKA presidents.
